Successful experience in **Manufacturing/Supply & Delivery of 2000 LITER Cation and 3000 LITTEr Anion Resin FOR CHEMICAL DEPARTMENT** in a **Single order of Rs 7.42 Lakh / Two order each of Rs. 4.64 lakh in a year / Three order each of Rs 3.71 lakh in a year since last three years ending 31.03.16** to any plant, preferably Thermal Power Plant.
