Dry Fly Ash from Ash Silos of STPS & BkTPS of WBPDC**

The West Bengal Power Development Corporation Ltd. (WBPDC) a wholly owned company of Government of West Bengal, having Corporate Office at 'Bidyut Unnayan Bhaban', 3/C, Block-LA, Sector-III, Salt Lake City, Kolkata-700 098. The WBPDC is the state Power Generating Company in the West Bengal having total installed capacity of 4865 MW with generating stations at Kolaghat (6X210MW), Bandel (4X 60MW + 215MW), Santhaldih (2X250MW), Bakreswar (5X210MW) and Sagardighi (2X300MW + 2X500MW).

1. Introduction & Objective of this Invitation for Expression of Interest (EOI)

1.1 The West Bengal Power Development Corporation Ltd. (WBPDC) is interested to utilize the Fly Ash generated from its power stations. For this purpose WBPDC invites Expression of Interest (EOI) from the interested, established and reputed business organizations. WBPDC has identified its plants at Santhaldih (STPS) and Bakreswar (BkTPS) for the said purpose.

1.2(a) STPS is located in the district of Purulia at a distance 316 Km (approx.) from Kolkata and nearest railway station is Santhaldih on South Eastern Railway of Adra-Bhojudi section.

(b) BkTPS is located in the district of Birbhum at a distance 250 Km (approx.)

from Kolkata and nearest railway station is Chinpai on Eastern Railway of Andal-Sainthia section.

1.3 Land for setting up the plant available with WBPDC. WBPDC will provide the land to the bidder on a long terms lease basis at a pre-determined fixed fee (one-time/ annual).

1.4 The bidder has to pay to WBPDC a sum as annual/ monthly fee for running the plant.

1.5 The bidder whose offer will be the highest will be selected.

1.6 WBPDC will be at liberty to terminate/ void the agreement/licensee to the bidder and the take back the land, if the bidder fails to start and operate the plant within the specified time frame.

1.7 The bidder has to take fly ash from the plants of WBPDC at STPS and BkTPS at a nominal pre-determined fixed rate. The price is subject to upward revision at every three years. The arrangements for collection and transportation of fly ash from the silos to the cement plant have to be arranged by the bidder.

1.8 The bidder has to lift per annum (a) 3.6 lakh MT fly ash from STPS and (b) 7 lakh MT fly ash from BkTPS.

3. Expected qualification of the Bidders in response to this EOI

3.1 The bidder must have experience in the Cement industry that has been operating plants of total production of 3 Mtpa (Million Tonne per Annum) including marketing of its product.

3.2 Further, the experience should include running at least 1 Mtpa (Million Tonne per Annum) or more single location capacity modern technology plant, at least for one year.

3.3 Adequate financial soundness with Rs. 200 Crore or more turn over on an average in the last three financial years.

3.4 Respondents need to submit the requisite documents as proof to meet the above eligibility criteria.

4. Facilities to be extended by WBPDC

4.1 LAND: Land for setting up the plant is available with WBPDC. WBPDC will provide the land to the bidder on a long term lease basis at a pre-determined fixed fee (one-time/ annual).

4.2 WATER: Will be provided on chargeable basis.

4.3 ELECTRICITY: Will be provided on chargeable basis.

4.4 Separate Vehicle Parking facility outside the plant premises.

4.5 All other materials, facilities required for installation and running of the cement plant has to be arranged by the bidder.

4.6 CONNECTIVITY: Both STPS and BkTPS are well connected with rail and road. Nearest station for STPS is Santhaldih and for BkTPS is Chinpai. (amendment)

5. Scope

5.1 The broad scope of installation and running of Cement plant at STPS and BkTPS units of WBPDC.

5.2 Necessary statutory clearances for installation and running of Cement plant at STPS and BkTPS have to be obtained by the bidder.

5.3 The bidder should inspect the sites at STPS and BkTPS and should confirm himself about the location, available facilities and parameters of the fly ash to be provided by WBPDC. The parameters of fly ash as mentioned in this EoI are representative and WBPDC is not anyway responsible for any change of the properties of fly ash.

(a) One plant of capacity 1 MTPA for STPS

and

(b) Two plants of capacity 1 MTPA each for BkTPS
