B) Scope of Job:

i) Receipt and Delivery of official Letters, Documents, Stationeries, Parcels etc. to and fro Corporate Office, WBPDC to K.T.P.S. Except holidays i.e. (Sunday & Other holidays).

ii) You are to undertake receipt & delivery of Letters, Documents, Stationeries, Parcels etc. without any weight limitation from the "Kolaghat Thermal Power Station, P.O.-Mecheda, Dist-Purba Medinipur", in the morning and deliver the same to the "WBPDC, Corporate Office at Bidyut Unnayan Bhaban, 3/C, Block-LA, Sector-III, Saltlake City, Kolkata-700098 within 4.00 P.M. everyday.
