The contribution amount can be paid in lump-sum or in 03 (three) equated monthly installment (EMI) in Cash / Demand Draft (in favor of 'THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED' payable at Kolkata) at either BTPS / KTPS / STPS / BkTPS / SgTPP / Corporate Office, Cash Section (working days only) latest by 29th September, 2018. In case the contribution amount is paid in EMI, the incumbent ought to invariably deposit all the EMI(s) at the respective unit where the initial payment is made.

Retired employees covered under CPF depositing respective contribution amount are required to retain the cash receipt number to be provided as reference along with the WBPDCL Medical Scheme for the Retired Employees, 2018 proposal form (Annexure A).

Retired employees covered under CPF who have already submitted their proposal form in line with circular issued vide Memo No.: COHRA05010006/2687 dated 02.07.2018, on deposition of the contribution amount at the respective Cash section, shall be required to retain a copy of the money receipt and fill-up the Annexure A1 (available with the site / corporate HR&A department) at the site / corporate HR&A office for updating of records.

The Company reserves the right to review the payment of such contributory amount and may at intervals fix up further amount on actuarial valuation basis, if required, to be deposited with the Company. The decision of the Company shall be final and binding on all ex-employees who are under CPF and availing of this WBPDCL Medical Scheme for the Retired Employees, 2018.

Concerned HODs of the respective site HR&A department are directed to forward the monthly contribution / collection status of the CPF covered retire employees (including widow, widower of any CPF covered ex-employee), in soft copy report (in .xls format) as per layout provided in Annexure B1 to the Corporate Office addressed to the Director (HR), WBPDCL positively by the 5th day of the following month.
