Consultancy Services for preparation of DPR for the following work:-

**Construction of community Hall at Kolaghat Thermal Power Station Township, adjacent to Rostrum situated near Market Complex of B-type area.**

**A. Brief Details of the Project:-**

The proposed community Hall will be used for conducting short duration programme like Marriage ceremony, Birthday party, Union/Association's meeting/get-together. Two storied building will be preferred so that upper storey may be used as transit accommodation for guest. Linking of existing Rostrum with the proposed construction is preferred for utilization of the same for the said purpose. However provision should be made for isolation of the Rostrum from the proposed one for performing functions like Mela etc. Community Hall should be designed to accommodate 500 persons in each storey of the said two storied building.

**B. Completion time for preparation of DPR:-**

All the detailed project report and associated drawings should be completed as per relevant I.S specification and direction of Engineer in Charge and should be submitted in ten copies within 90days from the date of issue of the work order. However PPR(Preliminary Project Report) should be submitted within 30days from the date of issue of the work order.

**C. Scope of Work:-**

Preparation of detailed project report and associated drawings as per existing rules and regulations including surveying, soil test, preparation of drawing for tender purpose, bill of quantities to be put to tender along with analysis of rate as per PWD(W.B) Schedule of rates and current market rate for the items which will not include in PWD(W.B) Schedule of rates and program of work in M.S project.

**D. Eligibility of the Bidder:-**

- i) The bidder should have experience in working with the statutory organization/undertaking/Govt. department under Govt. of West Bengal.
- ii) The bidder should be successfully completed or in the process of executing similar type of projects.
- iii) The bidder should have permanent design cum drawing office and should have in house expertise, constituted of team of Architect, Structural Engineer, and Drafts man experienced in Auto Cad.
- iv) The Bidder should have also relevant in house software and hardware.
