Kolaghat Thermal Power Station invites 4 (four) Part sealed tenders from eligible manufacturers only having sound technical experience and financial capability for supply of Economiser Coil for O/H of Unit #4 at Kolaghat Thermal Power Station (6 x 210 MW) as per terms and conditions detailed in tender document which will be issued by Sr. Manager (S&P), KTPS against deposition of Rs. 2,000/- (Two Thousand) towards the cost of tender document in cash only at KTPS Cash Section from 07.05.13 to 16.05.13 between 10 A.M. to 1.00 P.M. except Saturdays, Sundays & Holidays. Tender papers will not be issued against DD /Money Order/ Cheque and by post.

04. **Earnest money:** Rs. 70,000/- (Bank Guarantee or DD on Scheduled Bank only). Govt./ Govt. Undertaking/SSI/NSIC units are exempted from deposition of E.M. Valid documents shall have to be submitted along with tender for claiming exemption.

05. **Qualifying Requirement:**

- i) Must be a manufacturer of Coils/ panels of Economiser Superheaters or Reheaters for Steam Generators and such manufactured Coils/ Panels should be in successful operation of atleast 02 (two) Nos. Coal Fired Steam Generators for Power Plant units of 200 MW and above capacity, for a period not less than 02 (two) years as on Bid opening date. End user's certificate is to be submitted to ascertain the performance.
- ii) Must have the experience of supply of same/ more quantity of Economiser Coil as mentioned above in a single order within a span of last five years to any Govt./ Govt. Undertaking of reputed industrial house and to any power plant of National Thermal Power Corporation (NTPC) may take part in the tendering process. Documents in support of such supply have to be submitted.  
Moreover, documents to prove the experience of the tenderers in successful completion of supply of Economiser coil within a span of last five years for 210 MW power stations or above directly have to be submitted. These documents include purchase orders and successful completion certificate. The completion certificate should clearly indicate the name, reference of PO numbers, quantity, schedule date of completion, actual date of completion, reasons for delay in supply, if any. Repeat orders would also be considered as credential if the completion certificate (GRN) of the previous order of the same power station is submitted.
- iii) Bidder shall not assign or sublet the contract to any other sub-vendor.
- iv) OEM of KTPS is eligible.

06. Tender may be cancelled at any stage without assigning any reason whatsoever.
