Bakreswar Thermal Power Project (BkTPP) invites 4-part offer [Part I – Bid Guarantee (EMD), Part II - Pre bid qualification, Part III - Techno Commercial Offer, Part IV - Price Offer] for undertaking the Overhauling of Ash Handling Plant of Unit# 4 of BkTPP

Issue of Tender Document: The tender document shall be available from the **Contract Cell, Technical Building (4th floor), BkTPP** from 09:00 Hrs. to 11:30 Hrs. and 14:30 Hrs. to 17:00 Hrs. except Holidays & Sundays. **For collection of tender paper, the agency must send their authorized person with office stamp/seal.**

(14) **Qualification of the Bidder :** The tender is open to any single Bidder who is a well established and reputed company meeting the following requirements :

a) **Working Experience:**

i) The vendor should be well experienced in **Overhauling of Ash Handling Plant having Wet and Dry mode of Ash conveying system of any 210 MW/250 MW unit in AHP.** Experience list and performance certificate for last five years from the end-user and photo copy of orders are to be furnished along with the offer .Original order may be shown if required.

ii) **The bidder should have executed as on date of submission of Bid at least**

a) One similar work of value not less than the amount equal to Rs 10 Lacs

b) Two similar works of value of each not less than the amount equal to Rs 6.5 Lacs

c) Three similar works of value of each not less than the amount equal to Rs 5.0 Lacs

d) The orders executed [if more than one order submitted] must be completed within one year span.

iii) **Experience list and performance certificate from the end-user or repeat Order/extension order and photo copy of orders are to be furnished along with the offer. Approval Letter from end user as engagement as Sub-contractor is to be furnished, otherwise experience of Sub-contracting will not be considered. Only supply of manpower shall not be considered as similar work.**

b) **Financial ability:**

The bidder should have adequate financial stability i.e. annual turnover shall be more than Rs. 15.00 Lacs (Rs. Fifteen Lacs) only and net worth not less than Rs.2.0 Lacs (Rs. Two Lacs) only in each of the last three years. The copy of audited accounts with report for each of the last three consecutive years has to be furnished along with the offer.

(15) **Price to be quoted :**

Lumpsum Contract Price: The bidder must quote contract price for undertaking the **Overhauling of Ash Handling Plant (210 MW Unit) of Unit# 4 of BkTPP** on net and firm basis as per scope detailed in tender document (excluding the service tax) including supply of manpower and allied expenses like accommodation, vehicle, overhead and profit, consumables, tools & tackles and other incidental expenses. Any conditional bidding with price variation cost will make the bid liable to cancellation. The bidder must indicate the breakup of the quoted contract price i.e. cost involvement for deployment of manpower (category-wise), consumables, tools & tackles, overhead expenses and profit of the bidder. Service tax, as applicable, will be paid extra against submission of pertinent document.

(16) **Period of Contract:** The period of contract shall be of maximum **35 days (Approx)** for the job from the actual date of commencement of work at site. The tentative date of Overhauling is scheduled to be held in the month of July-August 2013. However actual date will be communicated to the successful bidder in advance for mobilization.

The executed similar nature of Job must be done within 05 years as on date of submitting of Tender Bid of this NIT.**
 - ii) **The bidder should have executed as on date of submission of Bid at least**
 - e) One similar work of value not less than the amount equal to Rs 64 Lacs
 - f) Two similar works of value of each not less than the amount equal to Rs 40 Lacs
 - a) Three similar works of value of each not less than the amount equal to Rs 32 LacsThe orders executed [if more than one order submitted] must be completed within one year span.
 - iii) **Experience list and performance certificate from the end-user or repeat Order/extension order and photo copy of orders are to be furnished along with the offer. Approval Letter from end user as engagement as Sub-contractor is to be furnished, otherwise experience of Sub-contracting will not be considered. Only supply of manpower shall not be considered as similar work.**
 2. **Financial ability:**

The bidder should have adequate financial stability i.e. Average annual turnover shall be more than Rs. 1.2 Crores in consecutive last three years. And net worth not less than Rs. 15 lakhs in each of the last three years. The copy of audited accounts with report for last two consecutive years has to be furnished along with the offer.

16) Price to be quoted:

The bidder must quote Lumpsum Contract Price along with each job as per the scope of work detailed in the tender document (excluding the service tax) for Overhauling of ESP area of Unit # 4 & Erection Rectification & Re-commissioning of defectives Field, 1B1 & 1B2 of the Same ESP area as Additional job. Erection replacement & re-fitting of Emitting Electrodes Collecting plate shaft support and bushing Insulator etc and necessary needs. of Bakreswar Thermal Power Project including allied expenses like supply of manpower, accommodation, vehicle, overhead and profit, consumables, tools & tackles and other incidental expenses. This total contract value **will remain net & firm throughout the contract and any conditional bidding with price variation cost will make the bid liable to cancellation.** The bidder must indicate the breakup of the quoted L.S. contract price i.e. cost involvement for deployment of manpower (category-wise), consumables, tools & tackles, overhead expenses and profit of the bidder. Service tax, as applicable, will be paid extra against submission of proper document

- (14) **Period of contract:** Work will commence during the Overhauling period of Unit # 4, which is tentatively scheduled to be held during July-august 2013. However, the actual date of starting job will

be intimated by the concerned Controlling Officer in advance. **Total work is to be completed within thirty days from the actual date of starting of job at site.** Mobilization of manpower & necessary tools-tackles is to be done well in advance for job preparedness. Work shall be undertaken in concurrence with the execution department regarding availability of equipments, handover of site etc

(15) Consumables, Tools & tackles etc required for work: Shall be provided by the contractor free of cost.
