Sealed tenders in prescribed form are invited from the bona fide, interested, resourceful and experienced agencies for the work “Renewing of existing plant boundary wall by RCC Column & Beam Frame Structure with RCC Panel Wall etc. at STPS, Dist-Purulia, West Bengal” under The West Bengal Power Development Corporation Limited (The WBPDC) in four steps bid system.

Step- I : Deposition of requisite amount of Earnest Money.

Step- II : Qualifying Requirement:-

Submission of documents as per the following requirement:

- a) Valid I.T & S.T., VAT, Service Tax Registration Certificates, Professional Tax Clearance Certificates, Provident Fund A/c No., Trade License etc.
- b) Credential of execution of similar type of work, directly under the Government/ Quasi Govt. organization **during the period of last seven years** in the following manner :-
 - In single order → Executed value of work not less than Rs. 3.0 (three) crore.
 - In two orders → Executed value not less than Rs. 1.90 (one point nine) crore.
 - In three orders → Executed value not less than Rs. 1.5 (One point five) crore.
 - The completion certificate shall clearly indicate the main work order reference and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.
- c) Average annual turnover in last three financial years (viz. year 2011-12, 2012-13, 2013-14) Rs. 1.2 (one point two) crore.
- d) Average net worth in last three financial years – Must be positive.
- e) Audited balance sheet for last three consecutive years.

Step- III: Techno Commercial Terms and condition: All the pages of the tender document including all the documents (except particularly mentioned pages) to be submitted by the bidder shall be duly signed / authenticated and stamped in acceptance.

Step-IV: Price Bid - As per Annexure-I.
