BG shall be issued by an Indian Branch of any scheduled bank. Under no circumstances would any guarantee be accepted from any Regional Rural Bank or State Co-operative Bank or Urban Co-operative Bank. The Bank Guarantee shall remain valid for a period of **180 days** (with additional claim period of **60 days**) from the date of opening of the tender. Details of the above and the other terms and conditions have been specified in the Conditions of Contract. Earnest money (EMD) will not accrue interest at any stage.
