The exact period of agreement and exact terms and conditions will be communicated later during the tender phase. **The party shall source the raw materials from the state of West Bengal or adjacent states like Bihar, Jharkhand or Odisha.**

## **INFORMATION TO THE INTERESTED PARTIES**

## 1) Intent of the EOI

1.1) After completion of the EOI process, **tender on the respective job** (Supply of Biomass Pellets along with transportation) will be floated with specific scope and terms and conditions. Shortlisted bidders of EOI process will be allowed to participate in the tender process subject to fulfillment of tender eligibility criteria.

## 2) Scope of work

- 2.1) Successful bidder will be responsible for suppling the specified quantity of agro residue based Biomass Pellets during the contract period. Contract will be valid for six months from the date of letter of award. The scope of work under this package shall include supply, loading, transportation, and delivery of Biomass Pellets (Non- torrefied/ Torrefied ) at the Power plant as per the guaranteed parameters mentioned in table under 2.7 of the this EOI document.
- 2.2) Biomass pellets have to be delivered at the sites, viz. Sagardighi Thermal Power Plant (SgTPP) and Bakreswar Thermal Power Station (BkTPP) of WBPDCL from the manufacturing Units. Transportation arrangement will be fully under the scope of Supplier/Manufacturer. The consignment of Biomass Pellets shall be delivered at respective thermal power plant by covered Trucks/ Dumper with arrangement of waterproof cover and these shall be unloaded within the power plant at the area identified by WBPDCL Site for this purpose.
- 2.3) Every participating bidder should indicate the price of Biomass pellets and transportation cost separately in their EOI. The distance of manufacturing units or sourcing point from the plants to be mentioned in offer.
- 2.4) Transportation of Biomass Pellets have to be done through covered truck /Vehicle only. Sufficient measure to be taken during transportation so that no water ingress happens during transportation. Water ingress or quality degradation arising out during transportation, if any, will lead to cancellation of Lot and WBPDCL decision will be Final in this regard.
- **2.5)** WBPDCL will specify delivery schedule and supplier shall dispatch the consignment accordingly on daily/weekly basis. In case of award, the supplier shall start delivery of material within 30 days from the date of issuance of Lol/Letter of Award. WBPDCL may review the delivery clearance based on the readiness of equipment at site of WBPDCL.
- 2.6) Any short fall in supplying Biomass Pellets of agreed quantity for consecutive three months will attract penalty as per terms and condition of tender.
- **2.7)** The manufacturer/ supplier will guarantee the technical parameters of biomass pellets as given in the **Table 1 : (Comprising both non-torrefied/ torrefied )**
