## 1. General Guidance for e-tendering :

Interested bidders are requested to log on to the website <u>https://wbtenders.gov.in</u> to participate in the bid.

## 2. Registration of Bidders :

Bidders who are willing to take part in the process of e-tendering are required to obtain Digital Signature Certificate (DSC)from any authorized Certifying Authority (CA)under CCA, Govt. of India (viz.n Code Solutions ,Safes crypt, e-mudhra, TCS,MTNL,IDRBT ) or as mentioned in e-tendering portal of GOWB<u>https://wbtenders.gov.in</u>.DSC is given as a USB e-Token. After obtaining the Class II/III Digital Signature Certificate(DSC)from the approved CA, they are <u>required to register</u> the Digital Signature Certificates through there registration system available in the website.

# 3. Steps of the tender :

# Step – I: Earnest Money Deposit (EMD):Cover - I

a. The Earnest Money (EMD) or Bank guarantee in a sealed envelope should be deposited in physical form within 13 / 04 / 2020 up to 17 : 00 hr. to the address: Sr. Manager (Contract Cell), 2<sup>nd</sup> Floor, Administrative Building, Sagardighi Thermal Power Project, P.O: Manigram, Dist: Murshidabad, Pin.742237.

Bidders must furnish the Earnest Money Deposit (EMD) in the form of "Demand Draft/BC/BG" of amount of Rs 1,31,440/- (Rupees One Lakh thirty one thousand four hundred forty only) in the favour of "West Bengal Power Development Corporation Limited "payable at STATE BANK OF INDIA, Sagardighi branch (Code no. 11377) or, in the form of "Bank Guarantee "for one year having claim period of another 3 months on any Scheduled Bank incorporated in India. Bank Guarantee issued by Foreign Branches / Foreign Offices of such scheduled Banks should be counter guaranteed by the Indian Branch of that scheduled bank incorporated in India OR any branch of an International Bank situated in India or registered with Reserve Bank of India as a scheduled foreign bank OR any foreign bank which is not a scheduled bank in India provided the Bank Guarantee issued by such Bank is Counter guaranteed by any Scheduled Bank incorporated in India.

## b. Certificates of MSME / NSIC SSI units are not exempted from depositing EMD.

- **c.** EMD of the successful bidder will be returned after Successful completion of the job duly certified by the controlling officers.
- **d.** WBPDCL reserves the right of forfeiture of Earnest Money deposit in case the tenderer, after opening of tender, withdraws/amends/impairs/derogates/revokes his tender within the validity period or extension thereof.
- e. No interest will be payable by WBPDCL on the above Earnest Money.
- **f.** Earnest Money of unsuccessful tenderers shall be refunded to them after issuance of the confirmed service order to the successful Bidder.

## Step-II: Qualification bid & Techno-Commercial Bid: Cover - II

## A. SUBMISSION OF MANDATORY DOCUMENTS AS PER FOLLOWING CRITERIA

- 1. Valid PAN, GST Registration certificate, IT returns of last financial year or previous year, Provident Fund Registration Certificate and ESI registration certificate.
- 2. The bidder should have working experience of doing Annual Maintenance Contract under the scope of electrical maintenance department during the last 7 years period in a thermal power station of 200MW capacity or above. Executed order (indented job) value criterion:
- a) **In Single Order** Executing value of work not less than Rs 52,57,406/- in a single order per year or part thereof.
- b) **In two orders** Executing value of work not less than Rs. 32,85,879/- in each order per year or part thereof.
- c) **In three orders** Executing value of work not less than Rs. 26,28,703/- in each order per year or part thereof.

NB: Extension/ repeat order without discontinuation of work upto one year only may be treated as one order.

- 3. Financial documents to satisfy the criteria that the average annual turnover for consecutive three years within last 04 FY not less **than Rupees 19.71 lakh** and net worth should be positive in each year.
- 4. Scan copy of Scope of work, all the other terms & conditions (as per enclosures) duly signed must be uploaded as token of acceptance.
- 5. Non submission of any above document may disqualify the bidder.

**Other important Documents to be uploaded:** Audited balance Sheet & Profit & Loss Account for last 03 years (with auditor signature in each page with membership no) and PT Registration Certificate.

## Step-III :Price Bid ( BOQ) : Cover – III

### (To be uploaded in "Finance Cover")

The financial proposal should contain the following document in one cover (Finance cover).

The bidder is to quote the rate in the space marked for quoting rate in the BOQ.(Only downloaded copies of the above documents are to be uploaded, virus scanned and digitally signed by the bidder).Bidder must quote for ALL items mentioned in BOQ. BOQ sheet with all cells filed-up must be submitted in Financial Cover. Non-submission of this sheet under Financial cover and partial quoting will lead to rejection of the bid. Statutory Taxes as per Govt. rule will be paid extra.

### Advice to the Bidders:

Bid documents can be downloaded from the web site: <u>https://wbtenders.gov.in</u>.

Tenderers must deposit earnest money in a separate sealed envelope superscripting Earnest Money, tender notice number, phone no of party, name of the work and due date of opening. The envelope containing earnest money will be opened first. The Earnest Money (EMD) should be deposited in physical form and all other bids including the scan copy of EMD should be uploaded separately through Web site.
