General Information

• Introduction

The West Bengal Power Development Corporation Limited (WBPDCL) is a company owned by the Government of West Bengal with the goal to carry on interalia the business of electric power generation and supply in the state of West Bengal, India. The thermal power plants under WBPDCL are in Kolaghat, Bakreswar, Sagardighi, Santaldih and Bandel. The registered & Corporate Office of The West Bengal Power Development Corporation Limited has been functioning from its own office building at Plot– 3/C, LA-Block, Sector-III, Saltlake City, Kolkata-700 106. WBPDCL is having 17 units of different capacities of Five Thermal Power Plant in West Bengal. Santaldih Thermal Power Station (STPS) is one of the Power Stations of WBPDCL having capacity 500 MW(2X250MW). WBPDCL is State Thermal Power Generating Company caters 85% power of the state of West Bengal.

STPS produces approx. 8.75 lac M.Tons of Pond Ash annually. To utilize the Ash in gainful and sustainable manner as per the provisions of extant MOEF&CC Gazette Notifications, STPS intends to issue some of its Pond Ash "on free of cost basis" from it's ash ponds to **Eligible Projects** (as per extant MoEF & CC Gazette Notification) like Road Project / Mine backfilling / Agriculture / Brick Plants / Reclamation of low lying area etc.

Transportation cost shall be borne by the respective agencies at their own abide by all laws of land.

• Expression of Interest(EOI):

STPS invites Expression of Interest (EOI) from interested Ash Users executing **Eligible Projects** (as per extant MoEF & CC Gazette Notification) like Road Project / Mine backfilling / Agriculture / Brick Plants / Reclamation of low lying area etc. for issue of Pond Ash to these projects, in the prescribed **FORMAT** (Annexure- 3) from its ash ponds.

• Documents Required:

A: Documents to be submitted at the time of submission of response to EOI:

- 1. Standard prescribed format as per annexure 3
- 2. Documents detailing the Eligibility of the Project as defined in Extant Notification and / or policy.
- 3. Tentative time schedule of the project along with Expression of Interest.

B: Documents to be submitted during the execution of the Pond ash issue:

- 1. Daily Progress Report regarding No. of Trucks of Ash Received at STPS Site.
- 2. Quantity Received Certificate on Periodic basis as agreed with Engineer In Charge (EIC)
- 3. Affidavit for Ash Utilization as per extant MoEF & CC Gazette Notification on quarterly basis in format prescribed by Engineer In Charge (EIC).

• Allocation of Pond Ash Quantity:

Pond Ash quantity allocation to interested parties for qualified projects, will be done, till the available offered quantity is exhausted. Pond ash shall be issued free of cost.

In Case, some of the party(ies) / agency(ies) who have been allocated Ash through last Pond Ash Tender/Auction/EoI process, become eligible against this EoI for issue of pond Ash from the STPS, it should be mandatory on their part to lift all the Ash quantity allocated through Tender /Auction / EoI process, then only quantity allocated against this EoI will be issued for lifting.

Pond Ash shall be issued from the storage location (Ash Dyke / Pond including its lagoons / sections / extended portions etc.) of the respective ash ponds, on 'as is where is' basis.

• Terms and Conditions and General Guidelines:

- 1) Pond Ash shall be issued from the storage location to the recipient agencies, or their authorized representatives as may be agreed to in writing by the Engineer In Charge (EIC) considering Operational, Safety and Security issues.
- 2) Statutory / Regulatory compliances shall be binding upon all the agencies and STPS reserves its right to verify or get it verified at any point of time as per its discretion.
- 3) On allocation of Pond Ash against this EOI, recipient agencies shall have to submit duly notarized affidavit on Non judicial stamp paper of requisite value, certifying their commitment for the complete use of issued STPS's Pond ash as per intended use declared at the time of submission of response to the EOI, and also certifying commitment to adhere to all the applicable provisions specified vide extant Notification and other applicable statutory regulations.
- 4) After start of issue of pond ash from STPS, the recipient agency shall further submit at the end of each quarter (every three months), a duly notarized affidavit on Non judicial stamp paper of requisite value, certifying their actual and complete use of the issued Pond ash as per the intended use declared at the time of submission of response to the EOI, and also certifying their actual and full adherence to all the applicable provisions specified vide extant Notification and other applicable statutory regulations.
- 5) In case of any liability on STPS, in any manner that arises due to non-compliance of any applicable Environmental or other Norms, Rules, Guidelines and Statutory provisions by the recipient agency, the agency shall keep STPS effectively indemnified of any such liability. An indemnity bond in this direction as per specified format shall be submitted before start of lifting of Ash, by each recipient.
- 6) Interested Ash Users executing Project shall have to submit tentative time schedule of the project along with Expression of Interest.
- 7) In case Ash is being taken from multiple sources for a particular eligible project by the Ash recipient agency, it shall be the responsibility of the Ash recipient agency to ensure that there is a clear demarcation of chainages / dumping points for the STPS Ash so as to quickly and correctly issue certificate of receipt for the quantity of Ash supplied from STPS.
- 8) Evacuation of settled ash from ash pond should be by deploying Excavating Machineries & other accessories like pay loader, dozer, roller, dumpers, water tankers etc. with suitable approaches in different levels/stages of excavation, maintaining correct profile, slope & berm at respective levels without damaging the stability of the embankment alongwith dewatering process, if required.
- 9) Ash cutting, dumper loading, transportation and unloading at destination should be free from fugitive ash emission by arranging water sprinkling, dumper covering, etc maintaining all statutory and pollution control norms as well as all precautionary safety measures at the work site.
- 10) Work measurement, the pre & post level, for the defined zone of excavation and filling/dumping area should be under joint supervision as per standard methodology.
- 11) Mobilization of man-power & machinery should be within 10 days from the date of issue of the order including access with the highway, abiding by the central & state labour legislation. Rectification of the damaged pond embankment, if required, shall be carried out with clay soil maintaining proper compaction.
- 12) For ash disposal, "No Objection Certificate / Consent" from land owner / mines, regulatory authorities prior to work start is mandatory.
