1.1. INTRODUCTION

Santaldih Thermal Power Station (STPS), a Power Station of The West Bengal Power Development Corporation Limited (A Govt. Of West Bengal Enterprise), invites Expression of Interest(EOI) from applicants for empanelment of Agencies for production operation of Fly Ash Brick at the STPS. As per the requirement, STPS shall have an agreement with the Agency selected after reverse bidding for 5 years from the date of signing agreement.

The agreement term may be renewed for 3-year blocks on satisfactory performance of the MSMEs as well as at the sole discretion of the STPS/WBPDCL authority.

Prospective parties are requested to participate in the said EOI.

- 1.2.9. STPS reserves the right to reject or accept any or all applications, cancel/withdraw the EOI process without assigning any reason whatsoever and in such case, APPLICANT shall not have any claim arising out of such action.

1.3. APPLICATION SUBMISSION:

- 1.3.1. Applications are to be submitted online through the website https://wbtenders.gov.in. It will be one folder and all documents relating to financial capabilities and statutory documents and past experience need to be uploaded.
- 1.3.2. All documents should be in PDF format only.
- 1.3.3. The documents uploaded shall be virus scanned and digitally signed using the Digital Signature Certificate (DSC).
- 1.3.4. It is a two-part selection process so the EOI contains two Part: a) Application Submission and b) Reverse Bidding.
- 1.3.5. After first part evaluation shortlisted applicant will only be eligible for participation on the reverse bidding

SECTION-II INFORMATION TO APPLICANTS

2.1. INTRODUCTION

The West Bengal Power Development Corporation Limited (WBPDCL) is a company owned by the Government of West Bengal with the goal to carry on interalia the business of electric power generation and supply in the state of West Bengal, India. The thermal power plants under WBPDCL are in Kolaghat, Bakreswar, Sagardighi, Santaldih and Bandel. The registered & Corporate Office of The West Bengal Power Development Corporation Limited has been functioning from its own office building at Plot– 3/C, LA-Block, Sector-III, SaltLake City, Kolkata-700 106. WBPDCL is having 17 units of Five Thermal Power Plant in West Bengal. Santaldih Thermal Power Station (STPS) one of the Power Station of WBPDCl having capacity 500 MW(2X250MW). WBPDCL is State Thermal Power Generating Company caters 85% power of the state of West Bengal.

Fly ash is a by-product of Thermal Power Plant which generate after burning of Coal. So proper utilization of fly ash is a responsibility of thermal Power Plant. So, for proper utilization of fly ash STPS is exploring the possibilities for setting up a brick manufacturing unit at its premises and production of bricks for its own requirements and for supply of local demands.

Therefore, STPS invites Expression of Interest (EOI) from Company/Private Organization/ Entrepreneurs/ Sole Proprietorships/ Partnerships Cooperative Societies /Registered NGO/ Self Help Group (herein after called APPLICANT) for agreement of brick manufacturing production. The agreement shall be signed with applicant for 5 years and then renewal of three years block on satisfactory performance under discretion of WBPDCL authority. The applicant can submit their bid/application for production operation and maintenance the brick manufacturing Plant.

2.2. **OBJECTIVES**

The objectives of empanelling of Agencies are as follows

- i. To increase the utilization of Fly Ash of STPS in ecofriendly manner
- ii. To develop an agency for production of Fly Ash Brick
- iii. To promote the use of Fly Ash Brick in local area

2.3. ELIGIBILITY CRITERIA FOR PARTICIPATION

- 2.3.1. Company/Private Organization/ Entrepreneurs/ Sole Proprietorships/ Partnerships Cooperative Societies /Registered NGO/ Self Help Group (herein after called APPLICANT) having GSTN and PAN shall be eligible to participate in EOI (In case of individual only PAN is mandatory).
- 2.3.2. Initial Investment capacity of the Applicant should be minimum Rs.35 Lac.

2.4. FACILITIES FORTHE AGENCY

STPS authority shall give the following facilities for the Agency.

i. **Land:**Around2500 Sqm of land owned by STPS in township or outside Plant area shall be designated for the total set up of the Fly Ash Brick Plant and its allied infrastructure that is plant shed with office room (not furnished), toilet block, brickfield with fencing and Agency shall be allowed by the STPS to construct the said plant and infrastructure for the purpose of brick manufacturing.

The selected Agency in this regard will be allotted the above required space for an initial term of five(5) years on monthly rent as decided by the WBPDCL authority. The term may be renewed for 3-year blocks on satisfactory performance of the Agency as well as at the sole discretion of the WBPDCL authority.

- ii. **Electricity:**Electricity supply and connectivity to be arranged by the agency on their own risk & cost.
- iii. Water: Arrangement of water for day to day operation of the Plant to be done by the Agency on their own risk & cost. STPS may extend necessary institutional help.
- iv. STPS shall extend all institutional helps in getting requisite clearance from the statutory authorities (viz. in respect of

pollution, Consent to establish, Consent to Operate etc). But all application and persuasion of the same to be arranged by the Agency.

v. STPS authority or its Contractor working in the STPS premises shall procure fly ash brick from agency with a mutually agreed price.

2.5. SCOPE OF WORK FOR AGENCY

APPLICANT would be expected to do the following.

- i. Fly Ash to be collected by the Agency from the SILO of STPS at its own cost.
- ii. The Agency has to utilize at least 300MT per month and up to 600MT from STPS SILO. However Dry fly ash will be supplied subject to availability of requisite quantity of fly ash at STPS SILOs a relevant point of time.
- iii. Brick so manufactured shall be owned by the Agency.
- iv. Regular maintenance of the machine involved in Brick Manufacturing needs to be carried out by the Agency by qualified and trained staff and spares to be procured from the OEM. Agency shall execute the AMC order with the OEM within one month from the date of issuance of order for handing over the machine and the same shall be submitted to the Engineer in Charge and cost to be borne by the agency.
- v. The Agency shall have to supply Bricks to STPS or to any Vendor of STPS as mutually agreed rate on priority basis within 7 days of requisition from the STPS.
- vi. The Agency shall be responsible for the following:
 - a) Monthly rental to be paid for the use of STPS Land
 - b) STPS shall issue free fly ash to the agency, cost for loading, unloading and transport of Ash to be borne by the agency.
 - c) Transportation of dry fly ash from silo to ash brick manufacturing unit shall be done by the Agency through fully covered vehicle in an eco-friendly manner abiding by the rules & regulations of the West Bengal Pollution Control Board with all safety norms.
 - d) A yearly target amount of Fly Ash to be utilized for manufacturing of Brick.

- e) Quality Brick making confirming to IS 12843:2002
- f) Investment of working capital for selling of Bricks in market on cash & Credit
- g) Transportation of Bricks to market if required.
- h) Arrangement of raw materials that is OPC/PSC Cement of IS brand, Medium Sand, Stone Dust mixed with grit, Gypsum, lime if necessary.
- i) Necessary marketing activities for sale of Brick.
- j) The Agency shall be entirely responsible for safety and security of the Fly Ash Brick Manufacturing unit,infrastructure and other equipment.
- k) Agency will be responsible for procurement, installation, commissioning, day to day operation & maintenance of Brick Manufacturing unit at his own cost.
- Housekeeping: The Agency shall maintain good housekeeping in order to avoid fugitive emission and shall use proper PPEs for the workers of the ash brick manufacturing unit
- m) End User Certificate: The Agency shall have to submit end user certificate after completion of every financial year duly issued by registered Chartered Accountant. Format for End User Certificate is given in Annexure-5.
- n) After completion of the agreement agency should hand over clear site without any charge.
- Agency will not be allowed to use the land for any other business except Brick manufacturing and Brick storage purpose only.

2.6. **PROCEDURE FOR SUBMISSION OF APPLICATION**

Eligible APPLICANT may download the EOI and should submit filled in application form with all the Annexures given in Section-III.

2.7. CRITERIA FOR FINAL SELECTION OF AGENCY

REVERSE BIDDING:

After reviewing the eligibility of all the Applications, STPS authority will shortlist the best eligible applicants for auction/reverse bidding. A reverse bidding shall be held between the shortlisted agency. Before the reverse bidding the shortlisted agency shall have to deposit an EMD amount of Rs.2,00000/-(Two Lakh only), which will be return to the un successful agency without any interest.

RESERVE PRICE:

Reserve Price for reverse bidding will be estimate based on the following criteria.

- i. Six Months' rental for the use of STPS Land is Rs.12,000/-
- ii. A premium of 8% on six months' rent i.e. Rs.960/-.

Hence sub-total of **Reserve price approx. Rs.13,000/-**The bidders have to quote above the reserve price with an increment of minimum Rs 1000/- per bid. Participation of minimum two bidders shall be sufficient to conduct the auction. In case of re-auction, due to insufficiency of bidders, even a single quote above the reserve price shall be deemed to be a successful auction.

BID MONEY:

The H1 quote settled above the reserve price shall become the bid money. The H1 bidder shall deposit the one time bid money (nonrefundable) within 15 days of successful conduct of the auction. On deposit of bid money, the H1 bidder shall become the successful bidder. In case the H1 bidder does not deposit the bid money within the time frame, the H2 or subsequent bidder(s) shall be approached as to whether they are willing to deposit the bid money at H1 rate.

SPACE ALLOTMENT:

The successful bidder shall be allotted the required space on receipt of 3 months' rent. An agreement between the successful bidder and power plant authority shall be executed thereafter. The EMD shall be kept as security deposit till the termination of the agreement.

2.8. **PERFORMANCE GUARANTEE**

- a) After selection of Agency through reverse bidding, STPS will sign an agreement with the Agency for 5 years subject to the following performance guarantee.
- b) The Agency shall have to ensure the yearly target quantity of Fly Ash utilization, if the quantity of utilization is less than the target quantity i.e.300MT per Month and in totality 3600MT per annum then party may impose for non-performance.

c) The STPS reserves the right to close/cancel the contract at any stage in case of non-performance or without assigning any reason whatsoever.

2.9. **PERFORMANCE SECURITY**

The amount of the EMD deposited before participation of the Auction/reverse bidding shall be kept as security deposit till the termination of the agreement.

2.10. TERMINATION OF CONTRACT:

The contract will be terminated by the following cause:

- i. In case the lease land is found being used for any other purpose
- ii. Violation of pollution norms
- iii. Monthly rent due for more the six (6) months.
- iv. Dry fly ash not lifted more than six (6) months
