13. All the beverage items may not be required at a time. WBPDCCL shall reserve the right for decide upon which beverage item to be dispensed.
14. In case of breakdown, it will be responsibility of agency to replace or repair the machine within 01(one) working hour from the time against complaints, if any.
15. The bill (for supply of Tea bags & coffee etc. as per meter reading which will be taken once in a month in presence of authorized representative of the WBPDCCL) to be submitted on monthly basis within completion of 07(seven) days of the calendar month.
16. The management reserves the right to terminate the contract with 07(seven) days' notice if performance/service is found to be non-satisfactory.
