1.0 Kolaghat Thermal Power Station (KTPS) of The West Bengal Power Development Corporation Ltd. (WBPDC) invites sealed tenders containing technical, commercial and price offer in duplicate (one original & one copy) from eligible bidders for Design, Manufacturing, Assembly, Testing at Manufacturing Works, supply, delivery & transport including transit insurance of Grinding Ring & Balls for 8.5 (10) Coal Mill at Stage-I.

2.0 Schedule of Completion of Supply

- i) First Phase of supply shall be completed by -- 02 (Two) months from the date of issue of Letter of Award. Quantity: 03 (Three) Sets
- ii) Second Phase of supply shall be completed by --04 (four) months from the date of issue of Letter of Award. Quantity: 03 (Three) Sets
- iii) Third Phase of supply shall be completed by—06 (Six) months from the date of issue of Letter of Award. Quantity: 04 (Four) Sets

3.0 Details of Tender

On presentation of requisite money receipt against applicable cost of tender documents, will be handed over to the respective Bidder (s).

All bids must be accompanied by a security as bid security/bid guarantee submitted in a separate sealed envelope in the following mode:

By Demand Draft /Pay Order / Bankers' Cheque / Demand Pay – INR 6,29,000.00 (Rupees Six Lac Twenty-Nine Thousand only) from any scheduled bank authorized to do the business in India. Demand Draft /Pay Orders / Bankers' Cheque / Demand Pay will be in the name of "The West Bengal Power Development Corporation Ltd." And payable at Mecheda. Payment in any other form e.g.: NSC, KVP, BG etc will not be accepted.

Details of the above and the other terms and conditions have been specified in the Conditions of Contract.

Govt./ Govt. Undertaking/NSIC units are exempted from deposition of Earnest Money on submission of Valid documentary evidences as per discretion of WBPDC authority. No Acknowledgement / Memorandum will be considered as valid certificate for EMD exemption.

4.0 Scope of Work/Supply

Supply of Grinding Ring & Ball sets for 8.5E (10) Coal Mill for KTPS, Stage-I, as detailed below:

5.0 Qualification Requirement and Eligibility Criteria for Bidders

5.1 The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conditions as laid down in the Bid Document is liable to be rejected.

MUST CONDITIONS

Technical

1. The bidder should be a manufacturer of Hi-Chrome Grinding balls of size 654 mm Dia. & Ni-Hard grinding ring set for Ball Mills & should have supplied grinding ring & balls during last Seven (07) years as on the date of bid opening, directly under the Government/ Quasi Govt. Organization/ Reputed Private Company (as per discretion of WBPDC), as any of the following:

a) One executed order containing Grinding Ring & ball sets together of same specification as per our scope of supply and mentioning Guarantee Clause therein as "satisfactorily run, in coal mill of any power utility having generation capacity of at least 210 MW, at least for a period of 8000 hours from the date of commissioning of the same", along with Goods Received Note (GRN) or Material Despatch clearance Certificate from the End-users, having value not less than Rs.2,51,43,464.00 (with taxes).

OR

b) Two executed orders containing Grinding Ring & ball sets together of same specification as per our scope of supply and mentioning Guarantee Clause therein as "satisfactorily run, in coal mill of any power utility having generation capacity of at least 210 MW, at least for a period of 8000 hours from the date of commissioning of the same", along with Goods Received Note (GRN) or Material Despatch clearance Certificate from the End-users, having value not less than Rs.1,57,14,665.00 (with taxes) each.

OR

c) Three executed orders containing Grinding Ring & ball sets together of same specification as per our scope of supply and mentioning Guarantee Clause therein as "satisfactorily run, in coal mill of any power utility having generation capacity of at least 210 MW, at least for a period of 8000 hours from the date of commissioning of the same", along with Goods Received Note (GRN) or Material Despatch clearance Certificate from the End-users, of value not less than Rs.1,25,71,732.00 (with taxes) each.

Financial

1. a) Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years i.e. up to FY 2016-17.

b) Has a minimum average annual turnover of Indian Rupees 94.29 Lacs of the last three financial years, up to F.Y. 2016-17.

c) Average Annual Net worth in last three financial years (up to F.Y. 2016-17) should be positive.

d) Current & valid Trade License, GST registration certificate and Copy of PAN should be submitted with offer.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-1 (Form-I) of Section-V of the tender documents.

AND

5.2 In addition to the requirements stipulated at Para 5.1 above, the Bidder should also meet, the requisite qualifying requirements/ must conditions stipulated herein under :-

5.2.1 The Bidder shall submit along with his bid a list of major similar supply of executed/being executed continuously by him during last 07 years giving detailed particulars such as quantity, Size, contract value, name of the Owner, year of commissioning, etc.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-I of the tender documents.

AND

5.3 Bidder shall strictly comply with the 'Delivery' schedule as detailed elsewhere in this document. Bid shall be rejected in case of any departure in this regard.

5.4 Evaluation of WBPDCCL shall be based on the information submitted by the bidder in response to these documents. WBPDCCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.

5.5 The bidder shall declare the specified key information for himself whichever is applicable in the table enclosed in Attachment-5 of Section-V.

5.6 The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant extra documents for its scrutiny during evaluation of Bidder's bid.

6.0 On the basis of a written application, tender documents, will be available from the office of Sr. Manager (Purchase), KTPS, Mecheda, from Monday to Friday (excluding Saturday, Sundays & Holidays) from 10.30 Hours to 14.00 Hours during all working days against payment of cost of the tender document by cash or by crossed Demand Draft drawn in favour of "The West Bengal Power Development Corporation Limited" and payable at Mecheda, Purba Medinipur. WB.

- 7.0 Tender papers are not transferable. Cost of Bidding Documents is Nonrefundable.
- 8.0 The offer must accompany the Earnest Money as indicated above failing which it will be summarily rejected.
- 9.0 Any offer received after the expiry of the time prescribed for receiving completed tenders, will not be considered.
- 10.0 The WBPDCCL reserves the right to reject any tender or all tenders received or cancel entire tendering procedure at its discretion without assigning any reason whatsoever. In that case WBPDCCL will not be liable to reimburse any cost incurred by the participants.
- 11.0 The WBPDCCL is not necessarily bound to accept the lowest offer.
- 12.0 Issuance of bidding documents will not be construed to mean that such Bidders are automatically considered qualified.
