Procurement of Gypsum as a byproduct of Flue Gas De-Sulphurisation (FGD) Plant from Sagardighi Thermal Power Station of WBPDCL.

The West Bengal Power Development Corporation Ltd. (WBPDCL), an Enterprise of Government of West Bengal, has a mission to produce quality electricity in compliance with regulatory norms and introduce eco-friendly systems in its expansion programme. WBPDCL has choosen Sagardighi Thermal Power Project (SgTPP) as the first Power Station among the WBPDCL Plants for installation of the FGD System.

SgTPP is going to produce 50,000 MT per annum of Gypsum as a byproduct from its FGD plant tentatively from June, 2022. Quality of Gypsum shall be with following characteristics

- a) Purity 85-90%
- b) Moisture-10%
- c) Chloride- 150 ppm (max.)
