## 1. General Guidance for e-tendering :

Interested bidders are requested to log on to the website https://wbtenders.gov.in to participate.

# 2. Registration of Bidders :

Bidders who are willing to take part in the process of e-tendering are required to obtain Digital Signature Certificate (DSC) from any authorized Certifying Authority (CA) under CCA, Govt. of India(viz. n Code Solutions, Safes crypt, e-mudhra, TCS, MTNL, IDRBT) or as mentioned in e-tendering portal of GOWB <u>https://wbtenders.gov.in</u>.DSC is given as a USB e-Token. After obtaining the Class II/III Digital Signature Certificate (DSC)from the approved CA, they are <u>required to register</u> the Digital Signature Certificates through their registration system available in the website.

3. Step-I or Cover-I: <u>Earnest Money Deposit(EMD)</u>: The Earnest Money (EMD) or Bank guarantee should be deposited in physical form within 24/07/18 up to 15: 00 hr. to the address: Sr. Manager (Contract Cell), 2<sup>nd</sup> Floor, Administrative Building, Sagardighi Thermal Power Project, P.O: Manigram, Dist: Murshidabad, Pin: 742237 and a scanned copy of EMD in Portable Document Format must be uploaded in EMD cover or in step –I through the web site. Earnest money must be deposited in a separate sealed envelope superscripting Earnest Money, tender notice number, and phone no of party, name of the work. Earnest Money Deposit (EMD) must be deposit in the form of "Demand Draft" of amount Rs. 80,000/- in the favour of " The West Bengal Power Development Corporation Limited "payable at STATE BANK OF INDIA, Sagardighi branch(Code no. 11377)or, in the form of "Bank Guarantee "for one year having claim period of another 03 months on any Scheduled Bank incorporated in India. Bank Guarantee issued by Foreign Branches / Foreign Offices of such scheduled Banks should be counter guaranteed by the Indian Branch of that scheduled bank incorporated in India or any branch of an International Bank situated in India or registered with Reserve Bank of India as a scheduled foreign bank or any foreign bank which is not a scheduled bank in India provided the Bank Guarantee issued by such Bank is Counter

- a. **Place of submission:** Original DD/BG as Earnest Money Deposit (EMD) should be submitted in a sealed envelope to the office of the The Sr.Manager (Contract Cell), Sagardighi Thermal Power Project P.O: Monigram , P.S.: Sagardighi, District: Murshidabad , West Bengal PIN: 742237 .
- b. EMD of the successful bidder will be returned after Successful completion of the job duly certified by the controlling officer.
- c. WBPDCL reserves the right of forfeiture of Earnest Money deposit in case the tenderer, after opening of tender, withdraws/amends/impairs/derogates/revokes his tender within the validity period or extension thereof.
- d. No interest will be payable by WBPDCL on the above Earnest Money. Earnest Money of unsuccessful tenderers shall be refunded to them after issuance of the confirmed service order to the successful Bidder.
- e. Govt. organizations are exempted from submission of Earnest Money deposit against submission of acceptable (as per discretion of WBPDCL) documents.

**NSIC/SSI registered units are exempted from deposition of EMD**. In case of NSIC/SSI, scanned copy of the latest valid Certificate should be submitted /uploaded in "**Step-I(EMD)**" Cover in lieu of EMD /bid security.

## 4. Step-II or Cover-II: Prequalification requirement (PQR) and Techno commercial terms and condition: Mandatory Document to be uploaded:

 Valid PAN,GST Registration Certificate, IT returns of last financial year(ay 2017-18 or previous year) The bidder should have credential of executing similar work under Govt./quasi Govt. organization/any renowned private sector (Power generation capacity of 200MW or above) during the period of last seven years in the following manners.

The party has to upload following documents as technical credential.

- In single order Executing value of work not less than Rs. 16,00,000/- per year
- In two orders Executing value of work not less than Rs. 10,00,000/- per year per order.

• In three orders – Executing value of work not less than Rs. 8,00,000/- per year per order.

- NB: Extension/ repeat order without discontinuation of work only be treated as one order.
- Financial documents to satisfy the criteria that the average annual turnover not less than **Rs.6,00,000/-** and net worth should be positive.
- Note: <u>submission of tender without the above mentioned documents or submission with tampered documents will</u> <u>be rejected.</u>
- Techno-Commercial terms and conditions:

Techno-Commercial Bid to be uploaded after seal and signing in each page. No deviation is allowed.

- **5.** Other documents to be uploaded: ESI compliance certificate, Provident Fund Registration Certificate, Audited balance sheet (with auditor's signature in each page and membership number) of last three financial years .
- 6. Step-III or Cover –III: (Rate chart submission)

Bidder has to filled the unit rate in the format attached with NIT and Upload the same in Cover –III. **The Step-III** & IV will be opened at same day.

The financial proposal should contain the following document in one cover(Finance cover).

**Bill of Quantities (BOQ):** The bidder is to quote the rate in the space marked for quoting rate in the BOQ.(Only downloaded copies of the above documents are to be uploaded, virus scanned and digitally signed by the bidder).Bidder must quote for ALL items mentioned in BOQ . BOQ sheet with all cells filed-up must be submitted in Financial Cover. Non-submission of this sheet under financial cover and partial quoting will lead to rejection of the bid.
