Road Transportation Contract for Coal from Simlong Colliery of ECL Rajmahal Area to Bakreswar Thermal Power Project(BkTPP)

Sealed Tenders are invited from experienced parties in four part bidding system comprising of:

- Part I – Earnest Money,
- Part II – Qualifying Requirement
- Part III – Techno Commercial Bid
- Part IV - Price Bid (to be submitted online in the portal of M/s mjunction Services Limited).

1. Job Description:

Road Transportation of coal from Simlong Colliery, ECL to Bakreswar Thermal Power Project (BkTPP) by Dumpers, unloading at BkTPP.

Quantity of Coal to be transported:

Approximately **1.2 Lakh Metric Tonnes** of coal.

2. Sale of Tender:

Tender Documents will be available for sale from 30.10.2012 to 09.11.2012 from the WBPDC and mjunction's office on payment of Rs. 5,000/- only per set by way of Demand Draft drawn in favour of West Bengal Power Development Corporation Limited (WBPDC) payable at Kolkata. Alternatively, tender documents may be purchased from the office of the Deputy General Manager (FM), WBPDC on payment of Rs. 5,000/- in cash. Written application on the letter head of the company should be submitted for purchase of tender.

3. Qualifying requirements for bidders:-

1. The bidder must be engaged in the activity of road transportation of coal or other raw minerals by dumpers/tippers.
2. No Joint Venture /Consortium of Companies/ cooperatives will be allowed to take part in the bidding process. Experience obtained as a sub contractor will not be considered.
3. Submission of Bid: To submit a bid, the bidder must purchase the tender document in his name.
4. **MINIMUM QUALIFYING REQUIREMENT** : The bidders must have the following experience
 - i. Must have transported minimum 20,000 MT of coal or other raw minerals by road.
 - ii. Must have the above experience at least for three months in a financial year within the last three financial years (2011-2012,2010-2011,2009-2010).

- iii. Must have experience as stipulated above {i.e. in (i) & (ii) of this QR} for a minimum lead of 40 km.
- iv. Must have experience to supply the same as per conditions stipulated above {i.e. in (i), (ii) & (iii) of this QR} to Government / Public sector/ Utility/Industry
- v. The bidder should have a net worth of at least Rs 5 Crore as on 31.03.2012. The original document specifying net worth certified by a chartered accountant and countersigned by the authorized signatory of the bidder has to be submitted.
- vi. The bidder should have ownership of a fleet capable to transport at least 250 MT coal. (e.g. ownership of 25 dumpers of 16 MT capacity each so that the carrying capacity $16 \times 16 = 256$ MT). The bidder should also be willing to put all such vehicles in service for the execution of the contract. A declaration in this regard has to be submitted along with the Qualifying Requirements (Part II) of the bid.
- vii. The bidder should have a turnover of at least **Rs 20 Crore** in the last financial year (2011-12). The Audited balance sheet countersigned by the authorized signatory of the bidder has to be submitted.
- viii. List of dumpers/tippers as mentioned above along with the relevant papers (like valid pollution clearance certificate, blue book, road tax clearance token, valid insurance etc) including copy of permits with ownership details has to be furnished.
- ix. The bidder should have sufficient work strength/employee strength in respective field of work and exhaustive employee list along with their PF account details/documents for the last financial year and valid labour license should be submitted.
- x. The service provider must have / obtain interstate / national transportation permits for the vehicles owned by him. Photo copies of permit for vehicles already having the necessary permit should be submitted. The bidder will submit a declaration in a non- judicial stamp paper that he will obtain interstate / national permit after award of the job at his own cost & risk.

The bidder should furnish:

➤ Photocopy of PAN card of Owner.
➤ Photocopy of latest Service Tax/CST registration of Owner.
➤ Photocopy of Latest IT return for the last three financial years (i.e. F.Y. 2008 - 2009, 2009 -2010, 2010-2011).
➤ Photocopy of the last Service Tax Return Certificate.
➤ Audited Annual Accounts of the Owner for last 3 years (i.e. F.Y. 2008 - 2009, 2009 -2010, 2010-2011).

- xi. The bidder should be capable to keep the validity of offer for at least 45 days from the date of opening of price bid of the tender. Declaration of validity signed by the authorized signatory has to be submitted.
- xii. Bidder must have established/ capable to establish full fledged office (including computer, internet facility, telephone & fax etc) at Kolkata and requisite set up

at Simlong mines. A declaration of this effect needs to be submitted in the letter head of the participant bidders and submitted in the Part II of the tender along with qualification requirement.

5. Earnest Money:

To participate in the online negotiations, interested participant(s) are requested to submit refundable/adjustable Earnest Money Deposit (EMD) of Rs 5,00,000 (Five Lakhs payable by Demand Draft/ Bank Guarantee (BG) in favour of “WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED” payable at any Schedule Bank, mentioned in Annexure (provided in tender documents) .Validity of Bank Guarantee is 6 months with a claim period of additional 30 days on written application of DGM(Fuel Management).
