Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
 - b) Audited balance sheet to satisfy the **net worth** (for the year **2011–2012**) of the intending party **not less than Rs. 2 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- 2. a) The party must have experience of same job of Rubber Lining & FRP Lining on Tanks for **at least 03 years** at any Thermal Power Station of any capacity.
 - b) The party must have executed/continuing same job of Rubber Lining & FRP Lining on Tanks at any Thermal Power Station of any capacity, where single order value must exceed 2.5 lacs (LS) or Capacity of Tank (read Job) must exceed 45 Tons.
 - c) Party should have past experience of safe handling of Hazardous Chemicals such as Caustic Soda and Hydrochloric Acid (34%).

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.

Bid documents can be obtained on the basis of written application from Sr. Manager (contract cell), Sagardighi Thermal Power Project, WBPDCL, West Bengal, during working day on submission of tender cost at our Cash Section by cash only.

Tenderers must deposit earnest money by demand draft/pay order in favour of 'The West Bengal Power Development Corporation Limited' payable at SBI, SAGARDIGHI (code 11377) in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening. The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money. **No tender will be entertained without earnest money.**
