**1.0** The West Bengal Power Development Corporation Ltd. (WBPDCL) invites sealed tenders in sextuple from eligible bidders for Construction of plant roads and drains, on item rate basis, comprising of R.C.C works (box culvert/box drain sections etc.), water bound macadam, bituminous paving, seal coat, shoulder and curb, for their Phase – II Extension Units # 3 & 4 (2 X500 MW) of Sagardighi Thermal Power Project.

# 2.0 Time of Completion:

(i) 18 (eighteen) months from the date of issue of Letter for Award for complete roads and drains works for Stage–II.

# 3.0 Details of Tender:

## Special Note:-

On presentation of requisite money receipt against applicable cost of Construction of plant roads and drains tender documents, soft copy of the said SGRD2 tender document in CD form will, initially, be handed over to the respective Bidder (s) for their internal use. Subsequently, required number of hard copy / copies of the said tender documents will be handed over to the recipient of the soft copy

after close of sale of tender. If there is any disparity between soft copy and hard copy then the contents/statements/clauses/items/data/parameters recorded in the hard copy shall prevail

#### a) Cost of one set of tender document

[Indian Rupee (INR)] : INR. 20,000. By crossed Demand Draft/ Pay Order on any Scheduled or Nationalized bank drawn in favour of The West Bengal Power Development Corporation Limited and payable at Kolkata, West Bengal, India

e) **Bid Security**: All bids must be accompanied by a security as bid security/bid guarantee submitted in a separate sealed envelope in the following mode:

By Bank Guarantee – INR 3,000,000.00 (Rupees Three Million only) issued by any scheduled/nationalized bank. The Bank Guarantee shall remain valid for a period of 270 days from the date of opening of the tender with a claim period of additional 90 days.

Details of the above and the other terms and conditions have been specified in the Conditions of Contract.

## 4.0 Qualification Requirement and Eligibility Criteria for Bidders

The Bidder shall fulfill satisfactorily the eligibility criteria requirements as stipulated under and submit documentary evidences that:-

**4.1** Has executed at least two numbers of similar nature of works in two different work orders consisting of preparation of sub grade, granular sub base, WBM road works, Bituminous Macadam, Seal Coat, R. C. drains, Culvert etc. during the last 10 years on turnkey or item rate contracts each valuing not less than 75 million INR and which are in successful operation for not less than 03 (three) years as on date of opening of the bid. As a proof of the above the Bidder shall submit relevant end user's Certificates.

The Bidder shall furnish a comprehensive list of completed jobs and jobs under construction with scope of work, details of the Owner, construction details, dates when contract/s have been awarded and commissioned/handed over.

**4.2** a) Have adequate capability and capacity to perform the work covered under this package properly and expeditiously within the time period specified with all necessary materials/equipments/machineries, tools and tackles. List of machineries/equipments etc. likely to be deployed shall be submitted by the bidders.

b) Has an adequate, well established and equipped office set up for undertaking the work of planning and procurement activities, preparation of Bar Bending Schedules, fabrication drawings etc. as and when required.

b) Has an adequate field service organization to provide the necessary supervision during construction, erection and management services required for construction of the Road and drainage work as specified in the tender document.

**4.3** The average annual turnover of the bidder in each of the last three financial years on the date of bid opening shall not be less than INR 75 Million (Seventy five Million). Net worth of the bidder in each of the last three financial year shall not be less than INR 30 Million (Thirty Million).

Bidder has to submit annual reports including audited Profit & Loss Account and Balance Sheets for each of the last three financial years.

**5.0** On the basis of a written application, tender documents, will be available from the Office of The Director (Projects), WBPDCL, Bidyut Unnayan Bhawan, Plot No. – 3/C, Block – LA, Sector – III, Salt Lake City, Kolkata – 700 098, during the period as stipulated in clause no. 3C (excluding Saturdays, Sundays & Holidays) from 11.00 Hours (IST) to 15.00 Hours (IST) during all working days against payment of cost of the tender document by crossed demand draft /pay order on any scheduled bank drawn in favour of "The West Bengal Power Development Corporation Limited" and payable in Kolkata.

**8.0** The offer must accompany the Bid Security/ Bid Guarantee as indicated above failing which it will not be considered.
