- (i) Valid S.T., I.T, Professional Tax Clearance Certificates and Provident Fund A/c No.
- (ii) Credential of successful completion of not less than G+2 RCC frame structured building including Civil, Sanitary & Plumbing, Electrical work in the last 5 (five) years, directly under any Government Organisation/ Undertakings/ Autonomous bodies/ any reputed concern and shall be in defect/ trouble free use at least for 1 (one) year from the date of handing over. The completion certificate shall clearly indicate the main work order and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.

The work value for similar types job completed by the agency should be as follows:-

- a) In Single order of value not less than - Rs 1.70 crore;
- b) In two orders each of value not less than:- Rs. 1.00 crore;
- c) In three orders each of value not less than:-Rs. 80 lakh
