Description of the Work: An order for designing, engineering, manufacturing, supply, erection and commissioning of drinking water system for STPS township system at STPS. **as per 'Scope of Work' and 'Terms & Conditions' as stipulated in the main Tender Documents.**

Information to Bidders:

This is a Four Part bidding system containing Earnest Money (Part-I), Qualifying Requirement (Part-II), Techno-Commercial (Part-III) and Price Bid (Part-IV). The same will be received and evaluated by the WBPDCL, STPS from Technical and financial point of view to make a selection in the best interest of the WBPDCL, STPS for the complete work as covered in the Main Tender Document.

<u>Salient points are mentioned below (details will be available in the main tender</u> <u>document) & the tender papers will be issued to the competent parties only on the basis</u> <u>of fulfillment of these requirement. Issuance of tender documents will not be construed</u> <u>to mean that such bidders are automatically considered qualified for the entire tender</u> <u>process.</u>

1) <u>Earnest Money</u>: The Earnest Money of Rs. 4,00,000.00 (Rupees Four Lac Only) shall be deposited along with tender papers in the form of Bank Draft / Pay Order issued by any reputed Banks (preferably Nationalized Banks) from India in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" payable at Santaldih, Purulia or Kolkata Branch.

- 2) Completion Time: 12 Months
- 3) Estimated value: Rs.02 (Two) Crore.
- 4) Cost of Tender Paper: Rs. 5,000.00 (Rupees Five thousand only).

5) Eligible Criteria:

(A). Must have experience as follows:-

- **A1.** Bidder should have an adequate design, manufacturing and/or fabrication capability and capacity to perform the work properly and expeditiously within the time period specified.
- **A2.** Bidder should have an adequate project management organization covering the areas related to engineering of equipment/systems, interface engineering, procurement of equipments and necessary field services required for successful construction, testing and commissioning of all the specified equipments and systems covered in the scope of work for this contract.
- **A3.** Bidder should have established quality assurance systems and organization designed to achieve best levels of equipments/system reliability, both during his manufacturing and/or fabrication and field installation activities.

- A4. All Equipments, components and sub-systems offered in the tender are to be of proven design.
- **A5.** Bidder should have designed, engineered, manufactured, constructed and erected, commissioned at least two (2) nos. of similar type of Installation of minimum capacity of 100 m³/hr in two different projects in last 7 years, consisting of filtration units followed by disinfection system along with required pumping and other necessary accessories and which should be in successful operation for a period not less than one year on the date of opening of bid.
- **A6.** Bidder should have designed Engineered, supply erected and commissioned of underground cross country DI pipelines of at least 1 Km in last 7 years.
- **A7**. Experience of successful completion of similar works during last 07 years (Financial year) for which offer is invited, should be any of the following:-

a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

Or

b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost.

Or

c) One similar completed works costing not less than the amount equal to 80% of the estimated cost.

(B). Financial Capacity:

Party should be financially strong enough to carry out the subject job, preferably average bank a/c balance of Rs 60 lac. Audited balance sheet with profit & loss account for the last three years and Bank statement for last one year are to be submitted along with main tender documents in Qualifying Requirements. (i.e. Part – II of 4 part tender)

6) Sale of Tender Paper: Tender Forms will be issued against application of vendors, signed by authorized signatory, along with all relevant supporting documents in support & to establish his competency in the related field. Evaluation of competency will be done as per sole discretion of WBPDCL based on the documents submitted by the vendors, in line with the interest of WBPDCL.

(1) Sound Financial Capability as per point 5 B) above & (2) Credentials of executing similar type of job during last 07 years (Financial year) in which applications are invited should be either of the following:-

a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

Or

b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost.

Or

c) One similar completed works costing not less than the amount equal to 80% of the estimated cost.

6.1 : The WBPDCL reserves the right to cancel / accept the tender in absence of the required documents as per sole discretion of WBPDCL as deemed fit by the competent authority.

6.2 : Legible photocopies of all documents are to be submitted with counter signed by Vendor. Original copies of documents are to be produced on demand.

6.3 : The tender, Qualification of bidder (Part-II) shall contain the name, Residential Address, Phone Number, Fax Number of person(s) authorized to sign the tender for future contact.

6.4 : Capability of making Labour Payment within 10'Th of every month without looking forward for release of bill from F&A Dept., STPS.

6.5 : Capability to control the labours with sufficient command and confidence.

7) Pre-Bid Discussion & Site Visit: All the parties are requested to visit the site before attending the Pre Bid discussion which will be held at the Office of Sr. Manager (M&C), STPS on dt. 21.03.2013 at 15=00 Hrs. to provide any additional information, modification and furnish further clarification, if any, needed on the scope of work and tender documents. Any modification, improvisation or addendum to tender documents resolved in this discussion will also be an integral part of the tender documents. Parties not attending the pre-bid discussion are also liable to abide by the outcome of pre-bid discussion. All the parties are requested to attend the same.

Special Note:

So far the improvisation of the subject work is concerned, which is beneficial to WBDPCL, WBPDCL reserve the right to alter any term or condition or technical details prior to submission of bid. In that case the same will be intimated in black & white to all the parties, brought the tender paper.

8) <u>Last date of Submission of Complete Tenders and Opening of Part - I & II of the Bids</u>: 03.04.2013 up to 15=00 Hrs. and 03.04.2013 at 15=15 Hrs. respectively.

9) Opening of Tender:

- 9.1 :The tenders shall be opened in presence of representative of the Vendors at the time of date set for opening of tender as specified hereunder or in case any extension has been given thereto on the extended tender opening date and time notified to all the Vendors who have purchased the tender documents. Vendors' authorized representative (up to two persons) may attend the opening.
- 9.2 :The due date and time of opening of E.M.D. & Qualifying Requirement of bidder is after 15=15 Hrs. on **03.04.2013** After opening the main cover, the envelope containing EMD (Part-I) shall be opened first and if EMD of requisite amount in proper mode is found only then Qualifying Requirement (QR) (Part-II) shall be opened.
- 9.3 : Techno Commercial (Part-III) of tender of those Vendors who will be considered qualified in view of Part-I and Part-II by the WBPDCL, shall be opened subsequently on dt. 03.04.2013 or at a later date. The due date and time for opening of Techno Commercial part shall be duly intimated.
- 9.4 :Price Bid (Part-IV) of tender of those Vendors who will satisfy qualifying requirements and who will accept technical and commercial terms & conditions of this tender shall be opened subsequently on dt. **03.04.2013** or at a later date. The due date & time of opening of price bid will be duly intimated.

10) Evaluation of Tender:

- 10.1 :Issuance of tender documents will not mean that such Vendors are automatically considered qualified for the entire tender process.
- 10.2 :The WBPDCL reserves the right to itself to accept any tender or reject any or all tenders or cancel / withdraw the invitation for tender without assigning any reason for such decision. Such decision by the WBPDCL shall not be subject to question by any Vendor and the WBPDCL shall bear no liability consequent upon such decision and the Vendor shall have no claim in this regard against the WBPDCL.
- 10.3 :Evaluation by the WBPDCL shall be based on the information and documentary evidence submitted by the Vendor in response to the tender documents. The requirements as Page No. 3 of 4

stipulated in the tender notice and documents are the minimum and the WBPDCL has the right to request for additional information. The WBPDCL reserves its right to reject any tender, if in the opinion of the WBPDCL the qualification data / documentary evidence submitted by the Vendor is incomplete or Vendor is found not qualified to satisfactorily perform the work. The WBPDCL reserve the right to reject any tender if the Vendor is found to be disgualified by giving incorrect and / or false information.

- 10.4 :The WBPDCL does not bind itself to accept the lowest tender and also reserves the right to split the work amongst more than one Vendor and also reserves the right to reject any or all tender or cancel the tender without assigning any reason whatsoever.
- 10.5 :Notwithstanding, anything stated above or elsewhere, the WBPDCL reserves the right to asses the capability and capacity of the Vendor, should the circumstances warrant such assessment in the overall interest of the WBPDCL.
