After finalisation of the Step-II bid i.e. fulfillment of the qualifying requirement, the Techno-Commercial part i.e. **Step-III** bid will be opened. The Price-Part of the Bid i.e. **Step-IV** of the eligible tenderers of the Techno-commercial bid will be opened later on. All tenders including its various steps shall be opened in presence of the attending tenderers. The dates of opening of the Techno-Commercial Part & Price-Part shall be intimated to the competent tenderers in due course of time.
