Sealed tenders in prescribed form are invited from the bona fide, interested, resourceful and experienced agencies for the work “**Evacuation of settled ash from the ash pond no. 2 in eco-friendly manner at Santaldih Thermal Power Station, Purulia**” under The West Bengal Power Development Corporation Limited (The WBPDC) in three steps bid system.

Step- I : Deposition of requisite amount of Earnest Money.

Step- II : Submission of documents as per the following requirement :-

- a) Valid I.T & S.T., Service Tax Registration, Professional Tax Clearance, Certificates, Provident Fund A/c No. etc.
- b) Credential of excavation, transportation and disposal of settled ash/ earth/river sand etc., directly under the Government/ Quasi Govt. organization / Power Plant **during the period of last five years** in the following manner :-
 - In single order → Executed volume not less than **4 (four) lakh cu.m.**
 - In two orders → Executed volume not less than **2 (two) lakh cu.m.** in each order.
 - The completion certificate shall clearly indicate the main work order and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.
- c) Average annual turnover in last three financial years (viz. year 2009-10, 2010-11, 2011-12) - **Rs.4 (four) Crore.**
- d) Average net worth in last three financial years - **Rs.1.5 (one point five) Crore.**
- e) Audited balance sheet for last three consecutive years.

Step- III : Price Bid.

Job Description:

i) Excavation of settled ash [6(six) lakh m³] from the ash pond at Santaldih Thermal Power Station, Dist. Purulia, West Bengal and transportation, disposal of the same in eco-friendly manner beyond 10KM / 20KM radius in land /Coal Mines to be arranged by the agency itself.

Time of Completion: 6 (six) months from the date of placement of Letter of Award.

Earnest Money Deposit: Rs.8, 00,000.00 (Rupees eight lakh only) in the form of Demand Draft or Bank Guarantee, valid for six months (Format of BG is available in the GCC) in favour of “THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED” drawn on /issued by any Nationalized/Scheduled Bank, Kolkata. The requisite amount of earnest money shall be deposited along with tender papers in a separate sealed envelope. No tender will be entertained without Earnest Money.

Cost of Tender Paper: Rs.3000.00 (Rupees three thousand only) in cash only (Non refundable).
