Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
b) Audited balance sheet to satisfy the **net worth** for the year of **2010–2011 or 2011–2012** of the intending party **not less than Rs. 5 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- a) The Contractor should have **at least 02 years experience** for 415 V motor maintenance at site under any Govt. organizations/undertakings/Power utilities/Power Industries.
b) The bidder should be well experienced in executing similar type of contract having order value **at least Rs. 7 lakhs per annum** within a period of last five years.
