- (i) Valid S.T., I.T, VAT, Professional Tax Clearance Certificates and Provident Fund A/c No.
- (ii) Credential of successful completion of RCC framed structure residential building, hospital, club house etc. including, Sanitary & Plumbing, Electrical work and Air conditioning system in the last 5 (five) years, under any Government Organisation/ Undertakings/ Autonomous bodies/ any reputed organisation and shall be in use at least for 1 (one) year from the date of handing over. The completion certificate shall clearly indicate the main work order and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.

The WBPDCL does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDCL authority. Tender papers are not transferable.
