(b) <u>Credential</u>: The bidder shall have the experience to execute similar type of the work of total executed value not less than **Rs. 7 Lac** (Rupees Seven lac only) in a single contract during the last five years (05 years) directly under a Govt. organization/PSU. The bidder shall have to furnish authentic documents (like copy of final bill certificate, completion certificate and work orders along with schedule of works) in support of successful completion of similar type of work. The bidder shall have at his own disposal sufficient number of workers including supervisor.

• **Period of contract:** The period of contract shall be from the actual date of commencement of work at site and/or as per the period mentioned in the LOI/work order. Contract period may be extended without any price escalation i.e. at the same rate of the order at the discretion of WBPDCL provided the performance of the previous year is satisfactory
