Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
b) Audited balance sheet to satisfy the **net worth** for the year **2011–2012** of the intending party **not less than Rs. 1 lakh** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
2. Direct experience of repairing & total servicing of ILMS at any plant of WBPDC or NTPC or any other Private sector Thermal Power Plant within last 03 years.

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.

Bid documents can be obtained on the basis of written application from Sr. Manager (contract cell), Sagardighi Thermal Power Project, WBPDC, West Bengal, during working day on submission of tender cost at our Cash Section **by cash only**.

Tenderers must deposit earnest money by demand draft/pay order in favour of 'The West Bengal Power Development Corporation Limited' payable at SBI, SAGARDIGHI (code 11377) in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening. The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.

Tenderers must furnish the name, address for communication, mobile no. and mail no. of the contact person in the time of submission of tender papers.

The date of sale, receipt and opening of bids shall be as per the following schedule:
