Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- a) Valid PAN & VAT/Sales Tax Registration Certificate, IT return of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
b) Audited balance sheet to satisfy the **net worth** (for the years **2010–2011 or 2011–2012**) of the intending party **not less than Rs. 12 lacs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- a) Bidders should have at least three years experience to carry out AMC work of VVF driven elevators in any big installations.
b) The bidder should be well experienced in executing similar type of contract having order value at least **Rs. 16 lacs per annum** within a period of last five years.

Step-IV: Price Bid.

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
