Bakreswar Thermal Power Project (BkTPP) invites 4-part Bids [Part I – Bid Guarantee (EMD), Part II- Pre Bid Qualification, Part III- Techno Commercial Offer, Part IV- Price Offer] offer for undertaking the Unit # 1 Boiler Overhauling Jobs such as Boiler Pressure Parts, Air Pre-Heater, Coal Burners, High Pressure Valves, Safety Valves, SADC, Soot Blowers etc. for Boiler Efficiency Improvement.

- (1) **Issue of Tender Document:** The tender document shall be available from the **Contract Cell, Technical Building (4th floor), BkTPP** from 09:00 Hrs. to 11:30 Hrs. and 15:00 Hrs. to 17:00 Hrs. except Holidays & Sundays. **For collection of tender paper, the agency must send their authorized person with office stamp/seal.**
- (2) **Cost of Tender Document :** The tender document shall be issued against submission of non-refundable **Demand Draft/Pay order amounting Rs.500.00** (Rupees five hundred) only **drawn in favour of “The West Bengal Power Development Corporation Ltd ” payable at United Bank of India, at Bk.T.P.P. or any Nationalized Bank/Schedule Bank at Suri.** Tender paper shall not be issued against cash / cheque / money order or by post.

- (10) **The date & time of opening of price bid will be intimated in due course to the Techno-commercially successful bidder.**
- (11) **The Bid Guarantee is to be submitted along with the bid in the form of Demand Draft/Pay order amounting Rs. 1, 50,000/- (Rupees One Lakhs and Fifty Thousands) only drawn in favour of “The West Bengal Power Development Corporation Ltd ” payable at United Bank of India at Bakreswar T.P.P. or any Nationalized/Scheduled Bank payable at Suri.** The Bid Guarantee of unsuccessful bidder shall be released in due course of time without any interest but may be forfeited at the sole discretion of WBPDC in case of submission of any false document in support of technical or financial credential of the bidder. However, necessary relaxation in the Bid Guarantee amount may be allowed to the bidder, if they are governed by any particular Circular/Administrative order for a defined period,

- (12) coverable within the scope of the contract, on production of supporting documents. Original Order of relaxation is to be shown if required.
- (13) Acceptance of offers is subject to submission of valid Sales tax clearance certificate/VAT [up to date & if applicable], Professional Tax Clearance Certificate [up to date], Income Tax PAN No , Service Tax Registration No , PF code etc. along with the offer.
- (14) **Before preparing the tender for final submission, the agencies must collect all relevant information from the Dy.General Manager (HR&A), BkTPP regarding procedure of deployment of manpower, prevailing wages of unskilled manpower at BkTPP, Provident Fund, Workmen's Compensatory Insurance, Labour License and all other stipulated Rules & Regulations under the Factories act - 1948 & rules frame under Contract Labour (R&A) 1970 & rules framed there under, Minimum Wages act and other statutes applicable including Rules and Regulations connected thereto.**
- (15) The interested agencies may inspect the site & satisfy themselves before submission of tenders. The bidder must confirm in written while submitting the tender that he has quoted rates understanding the scope & area of work, all terms and conditions of tender documents, mode of deployment of manpower at BkTPP, actual site conditions & other related aspects. **For any clarification regarding Scope of works/area etc, the agency may contact Sr.Manager (Boiler Maint), BkTPP.** Deviation in any respect, expressed anywhere in the four part bid document, will not be accepted.
- (16) **Qualification of the Bidder :** The tender is open to any single Bidder who is a well established and reputed company meeting the following requirements :
- i) **The Bidder must be well experienced in Boiler Overhauling such as Boiler Pressure Parts, Tubular Air Pre-Heater, Coal Burners, High Pressure Valves, Safety Valves, SADC, Soot Blowers etc. of BHEL make Corner Fired 210 MW Boiler.** The executed Overhauling Job must be done within 05 years as on date of submitting of Tender Bid of this NIT.
 - ii) **Experience list and performance certificate from the end-user and photo copy of orders are to be furnished along with the offer**
 - iii) **Contract of similar nature i.e. Boiler Overhauling such as Boiler Pressure Parts, Tubular Air Pre-Heater, Coal Burners, High Pressure Valves, Safety Valves, SADC, Soot Blowers as mentioned in Sl. No. a(i) having single order value more than Rs. 80 lakhs (Rs Eighty lakhs) only within last 05 (five) years have to be submitted along with the offer.**
- b) **Financial ability:**

The bidder should have adequate financial stability i.e. annual turnover shall be more than Rs. 1.5 Crores (One and Half) and net worth not less than Rs. 15 lakhs (Fifteen) in each of the last two years. The copy of audited accounts with report for last two consecutive years has to be furnished along with the offer.

16) Price to be quoted:

The bidder must quote Lumpsum Contract Price along with rate of each optional job as per the scope of work detailed in the tender document (excluding the service tax) for Unit # 1 Boiler Overhauling such as Boiler Pressure Parts, Tubular Air Pre-Heater, Coal Burners, High Pressure Valves, Safety Valves, SADC, Soot Blowers.etc of Bakreswar Thermal Power Project including allied expenses like supply of manpower, accommodation, vehicle, overhead and profit, consumables, tools & tackles and other incidental expenses. This total contract value **will remain net & firm throughout the contract and any conditional bidding with price variation cost will make the bid liable to cancellation. The tender will be cancelled if rate of all optional jobs are not quoted.** Service tax, as applicable, will be paid extra against submission of proper document.

L-1 bidder will be considered by adding up of LS contract value with the total value of each optional job (rate for each job X tentative qty of each job).

17) Period of contract: Work will commence during the Overhauling period of Unit # 1, which is tentatively scheduled to be held during 'June-July'2013. However, the actual date of starting job will be intimated by the concerned Controlling Officer in advance. **Total work is to be completed within twenty days from the actual date of starting of job at site.** Work shall be undertaken in concurrence with the execution department regarding availability of equipments, handover of site etc.

18) Consumables, Tools & tackles etc required for work: Shall be provided by the contractor free of cost.

19) Apart from above following stipulations are to be adhered to :-

- ◆ Tender papers are not transferable.
- ◆ Any offer without aforesaid bid guarantee shall not be considered
- ◆ Any offer received after the last date & time stipulated in this notice shall not be considered.
- ◆ WBPDCCL reserves the right to reject/cancel any or all tenders at its discretion.
