- a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
- b) Audited balance sheet to satisfy the **net worth** for the year **2010-2011 or 2011-2012** of the intending party **not less than Rs. 5 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
2. a) The bidder should have minimum one(01) year experience in the field of fabrication & erection job in at least 200 MW or above power plant.

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
