- (ii) Credential of successful completion of two storied RCC framed structure residential building, hospital, club house etc. including, Sanitary & Plumbing, Electrical work, etc in a single contract/ sub-contract, in the last 5 (five) years, under any Government Organisation/ Undertakings/ Autonomous bodies/ any reputed organisation and shall be in use at least for 1 (one) year from the date of handing over. The completion certificate shall clearly indicate the main work order and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.
