Sealed Tender indicating the name of the job, NIT no. etc on the envelope in prescribed format are invited by Bakreswar Thermal Power Project (BkTTP) in 3-part Commercial (Part I – Bid Guarantee (EMD) Part II - Pre Bid qualification and Part III - Price Offer) offer from the appropriate class of bona fide and resourceful contractors who have acquired necessary credential for successful completion of similar type of job directly under the owner who is a Govt. organization / PSU, for undertaking the following jobs-

Name of the job: “Contract for drain cleaning, as and when required basis, at C.H.P area & other inside plant premises of BkTTP for the year 2013-2014.”

- Estimated cost: Rs. 21,54,879.00
- Cost of tender paper: Rs 1000.00 (non refundable)

Issue of Tender Document: The tender document shall be available from the Civil-IPH Dept, Technical Bldg. (3rd floor), BkTTP from 10:00 Hrs. to 12:00 Hrs. and from 14:30 Hrs to 17:00 Hrs except Holidays & Sundays. For collection of tender paper, the agency must send their authorized person with office stamp.

The tender document shall be issued against submission of non-refundable Demand Draft/Pay order amounting Rs.1000.00 (Rupees one thousand only) drawn in favour of “**The West Bengal Power Development Corporation Ltd**” payable at United Bank of India, Bk.T.P.P. Tender paper shall not be issued against cash/cheque/money order /post. . Request for issuing Tender Paper as well as submission of the same through Postal / Courier Service shall not be entertained.

The **Bid Guarantee (EMD)** is to be submitted along with the bid in the form of Demand Draft/Pay order amounting **Rs. 22,000.00** (Rupees twenty two thousand only) drawn in favour of “**The West Bengal Power Development Corporation Ltd**” payable at United Bank of India, Bk.T.P.P or any Nationalized bank at Suri. The Bid Guarantee (EMD) of unsuccessful bidder shall be released in due course of time without any interest but may be forfeited at the sole discretion of WBPDC in case of submission of any false document in support of technical or financial credential of the bidder. However, necessary relaxation in the Bid guarantee amount maybe allowed to the bidder, if they are governed by any particular Circular/Administrative order, providing for the same on production of supporting documents.

- **Submission of statutory documents:** Acceptance of offers is subject to submission of valid Professional tax clearance certificate [up to date], Income Tax [up to date], Service Tax registration No, Company PF Code No.

It shall be obligatory and imperative on the part of the Tenderer to collect all the relevant information and Data pertaining to the Tender in question including deployment of manpower, prevailing wages of unskilled manpower at BkTTP, requirement of extending Provident Fund, compliance with the provisions of Contract Labour (Regulation & Abolition) Act, 1970, Employees’ Compensation Act, 1923, Labour License and compliance with the provisions of Factories Act, 1948 and all other Statutory and related

Rules and Regulations and procedural formality in connection therewith and other requirements incidental thereto or connected therewith.

The interested agencies may inspect the site & satisfy themselves before submission of tenders. The bidder must confirm in writing while submitting the tender that he has quoted rates understanding the scope & area of work, all terms and conditions of tender documents, mode of deployment of manpower at BkTPP, actual site conditions & other related aspects. Deviation in any respect, expressed anywhere in the three part bid document, will not be accepted.

- **Qualification of the Bidder:** The tender is open to any single Bidder who is a well established and reputed company meeting the following criterion:

(a) Financial ability: The bidder shall have adequate financial stability i.e. annual turnover shall be more than **Rs. 28 Lac (twenty eight lac only)** and net worth not less than **Rs. 4 Lac (Four lac only)** during any one of last 3 years. The copy of audited accounts with report for last 3 (three) years shall have to be furnished along with the offer.

(b) Credential: The bidder shall have the experience to execute similar type of the work i.e labour oriented job, of total executed value not less than **Rs. 7 Lac** (Rupees Seven lac only) in a single contract during the last seven years (07 years) directly under the owner who is a Govt. organization/PSU.

The bidder shall have to furnish authentic documents (like copy of final bill certificate, completion certificate and work orders along with schedule of works) in support of successful completion of similar type of work. The bidder shall have at his own disposal sufficient number of workers including supervisor.

- **Period of contract:** The period of contract shall be from the actual date of commencement of work at site and/or as per the period mentioned in the LOI/work order. Contract period may be extended without any price escalation i.e. at the same rate of the order at the discretion of WBPDCCL provided the performance of the previous year is satisfactory

Apart from above following stipulations are to be adhered to:-

- ↳ Tender papers are not transferable.
- ↳ Any offer without aforesaid bid guarantee (EMD) shall not be considered.
- ↳ Any offer received after the last date & time stipulated in this notice shall not be considered.
- ↳ WBPDCCL reserves the right to reject any or all tenders at its discretion.
- ↳ WBPDCCL is not necessarily bound to accept the lowest offer.
- ↳ Issuance of tender paper will not ascertain the qualification of the Bidder.
- ↳ Any offer at any stage of evaluation may be rejected and the Bid Guarantee shall be forfeited at the sole discretion of WBPDCCL in case of submission of any false document in support of credential of the bidder.
- ↳ No deviation is allowed in respect of any terms & conditions detailed above and appended in the tender paper.
- ↳ Any tender having such deviation expressed anywhere in the bid may be liable for rejection.
- ↳ Jurisdiction regarding this contract is limited to State of West Bengal as per provisions of Statutes.
- ↳ WBPDCCL reserves the right to split the job among more than one bidder.

The Corporation reserves the right to accept or reject any or all tenders in full or part or to split the work, if necessary, without assigning any reason whatsoever. All other details will be available in the tender documents.
