 - b) Audited balance sheet to satisfy the **net worth** for the year **2010-11 or 2011–2012** of the intending party **not less than Rs. 45,000/-** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- 2. a) The bidder should have minimum three (03) years' experience & should own well equipped workshop.
 - b) The bidder should be well experienced in executing similar type of contract having total order value of at least **Rs. 60,000/- per annum** within a period of last two years.
