Request Inviting Expression of Interest for Consultancy services for preparation of Road Map to achieve the PAT targets for five Thermal Power stations under WBPDCL.

- 1. The West Bengal Power Development Corporation Limited (WBPDCL), a GoWB enterprise is the leading thermal power generating company in West Bengal having five thermal power stations in West Bengal under its control.
  - a. Kolaghat Thermal Power Station(6x210MW), Purba Medinipur, WB, Pin-721137
  - b. Bakreswar Thermal Power Project(5x210MW), Dt. Birbhum WB, Pin: 731104
  - c. Sagardighi Thermal Power Project(2x300MW), Dt. Murshidabad WB, Pin: 742226
  - d. Santaldih Thermal Power Project(2x250MW), Dt. Purulia WB, Pin: 723146
  - e. Bandel Thermal Power Station(4x60+1x210MW), Dt. Hooghly, WB, Pin: 712503
- WBPDCL now invites Expressions of Interest (EOI) to prequalify and shortlist Consultants for study & preparation of Road Map to achieve & sustain with the PAT targets for its existing Thermal Power stations

#### 3. Outline of the scope of services

Key outcome -

- a. Comprehensive roadmap to achieve the PAT targets set by BEE for 1<sup>st</sup> PAT cycle for all power generating stations under WBPDCL. The report shall necessarily include-
  - Identification of weaknesses in existing processes/ systems related to energy accounting, conversion & consumption
  - Best practices followed by top performing generating station in country & identification of practices that can be implemented at WBPDCL
  - Review results of earlier audit reports & recommendations
  - Recommendations for short term, medium term and long term action plan to achieve the PAT targets including cost benefit analysis
  - Priority listing of such schemes based on the benefits, time of completion, fund requirement etc
  - Suggestion of suitable strategies for implementing the action plan within 1<sup>st</sup> PAT cycle with funding options(PPP/ vendor tie-up etc)
- b. Support in preparation of PAT related documentation for submission to SDA, BEE, Regulatory commission, BoD approval etc

c. Complete understanding of the roadmap prepared by the vendor including actions suggested, their workability & sustainability through suitable awareness programs.

## 4. Outline of the Expression of interest

Expression of interest shall offer -

- Approach methodology towards preparation of the roadmap to achieve the targets
   & sustainability of such achievement
- Approximate timeline for such services in totality
- Supports required from WBPDCL
- Estimated cost

Vendors may be asked to make presentation before the WBPDCL management regarding their technical ability & approach methodology towards preparation of the roadmap

# 5. Tender Methodology

The tender methodology proposed to be adopted will be in two stages comprising of Expression of Interest (EOI) in the first stage. The second stage of tendering process will comprise of inviting techno-commercial bids by issuance of Request for Proposal (RFP) to EOI respondents, shortlisted on the basis of pre-qualification criteria mentioned Clause 4. The EOI process also envisages sharing the required technical expertise and experience with WBPDCL by the Consultants.

## 6. Qualifying Requirements (QR) for Consultants:

Expressions of Interest (EOI) are invited from the Consultants meeting the minimum qualifying requirements as mentioned below:

- a) Demonstrated capability in Indian power sector:
  - i. At least one project in Coal based Thermal Power Generation having installed cap> 400MW with at least one 200MW or above capacity unit
  - ii. At least two projects in Energy efficiency and demand-side management
- b) Relevant experience of working with the electricity generation stations/ Govt/ regulators
- Experience in developing Investment Grade Energy Audit Reports for thermal power stations
- d) Should have an annual turnover from Firm business of at least Rs. 10 (Ten) crores in the last 2 of the three financial years
- e) Should have been profitable for at least two (2) of the last three (3) years i.e. FY 2010-11, 2011-12 and 2012-2013
- f) The bidder should not be involved in any major litigation that may have an impact of affecting or compromising the delivery of services as required under this contract
- g) The bidder should not be black-listed by any Central / State Government / Public Sector Undertaking in India.
- h) The bidder must have at least five certified energy auditor (accredited by BEE)/ manager at their payroll who have performed similar jobs.

Testimonials / Documents supporting fulfillment of the QR mentioned in above must be submitted with the EOI as per Annexure-I

# 7. Other requirements for submission of Expression of Interest (EOI):

- a. Tax Clearance Certificate for the last three financial years
- b. Summary of similar projects/assignments executed or under execution by the Firms
- c. Last three years Annual Reports of the Firm

#### 8. Evaluation of EOI Responses

- The evaluation of EOI Responses and short listing of Respondents shall be on the basis of documents submitted to WBPDCL & presentation of their technical ability & the approach methodology
- b. WBPDCL can at its sole discretion short list or reject any of the EOI responses without assigning any reason whatsoever
- c. For documents to be submitted for pre qualification, refer to Annexures.
- d. WBPDCL reserves their right to evaluate the responses, based on technical & financial merits, in the process of short-listing and identification of the participants for further discussions.
