The West Bengal Power Development Corporation Limited invites sealed tenders in three part bidding system containing Earnest money (Part –I), Techno–commercial Part (Part-II) and Price offer (Part –III) for the following work at all the thermal power stations of The West Bengal Power Development Corporation Limited from interested, resourceful and experienced agencies:-

Job Description:

Annual Environmental Monitoring and submission of Annual Environment Statement for i) BkTPP, ii) KTPS, iii) BTPS, iv) STPS and v) SgTPP of WBPDCL

Tender paper for the aforesaid job will be issued against verification of the following documents in xerox along with the originals:

- (i) IT, ST, PT Clearance Certificates as applicable, PF Registration Certificate, P.F Code Number or suitable certificate bearing exemption to any or all of above from competent authority.
- (ii) Credential Certificate of satisfactory completion of work of Annual Environmental Monitoring and Preparation of Annual Environment Statement for any pulverized coal fired Thermal Power Station having unit capacity of 210 MW and above in any of the last three years.
- (iii) Statement embodying detail of manpower and list of equipments (duly approved by WBPCB) as will be engaged in the instant scope of work.
- (iv) Audited balance sheet for the last three years.

Duration of Contract: 12(twelve) months.

Earnest Money Deposit: Bank draft amounting to Rs 4000/- (Rupees four thousand only), for each Thermal Power Station, drawn on any nationalized/scheduled bank in favour of The West Bengal Power Development Corporation Ltd, is to be submitted along with tender papers in a separate sealed envelope. No tender will be entertained without Earnest Money.

Cost of Tender Paper: Rs.200.00 only in cash (non refundable) for each Thermal Power Station.

Sale of Tender Paper: 06.05.13 to 14.05.13 from 11-00 hrs. to 15-00 hrs. on all working days (except Saturday / Holiday)

Last date of submission of tender papers: 28.05.13 upto 14-00 hrs. The Part-I & Part -II bids will be opened at 15.30 hrs. on the same date in presence of the participating tenderers. Sealed tenders for Part-II will be opened only of the parties who have deposited the requisite amount of Earnest Money in Part-I. Price Bid i.e Part –III will be opened at a later date which will be intimated to the qualifying bidders of Part-I & Part –II bids.

Tender document can be obtained on written request to the Deputy General Manager (Env), WBPDCL, Kolkata - 700098, on the dates as mentioned above, after submission and verification of the above documents and thereafter depositing the cost for tender documents at our cash office.

The Corporation reserves the right to accept / cancel any or all tenders or to split the work without assigning any reason whatsoever. The WBPDCL does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDCL authority.
