(i) Posses valid VAT, IT, Professional Tax clearance certificate and Provident Fund A/C No., (ii) Have credentials regarding experience of execution of similar nature of jobs in a single contract valuing minimum

Rs. 80.00 Lakhs, done at least once during last five (5) years in directly under the owner i.e. Govt. Organisation /Undertaking Autonomous bodies, Reputed Industrial Houses under Indian Company's act (iii) also have documents holding possession of Labour License and Insurance as per Workmens' Compensation Act for such job., (iv) Audited Balance Sheet and Profit & Loss account for last three years. The total Net Worth of the intending party should not be less than Rs.50.00 Lakhs. Solvency certificate from chartered accountant to be submitted.

Postal correspondence in this regard will not be entertained at all. A Pre Bid discussion shall be held on **-21.06.2013** at **3-30 PM** with the tenderers and the minutes of the said discussion shall be taken into account as a part of tender specification. Attending the **Pre-Bid** discussion is mandatory.

Sealed tenders of the parties who have deposited the requisite amount of Earnest Money in Step-I of the bid; the Step-II bid thereof will be opened subsequently. After finalisation of the Step-II bid i.e. fulfillment of the qualifying requirement, the Techno-Commercial part i.e. Step-III bid will be opened, the price part of the Bid i.e.Step-IV of the eligible tenderers of the Techno-Commercial bid will be opened later on. All tenders including its various parts shall be opened in presence of tenderers. The dates of opening of the Techno-Commercial Part & Price Part shall be intimated to the competent tenderers in due course of time. The Earnest Money (interest free) should be deposited along with the tender offer in the form of Bank Draft /Call Deposit only on SBI/UBI/UCO/PNB, Mecheda Branch in favour of "The West Bengal Power Development Corporation Ltd." in separate sealed envelope. No tender will be entertained without Earnest Money.

The Corporation reserves the right to accept/cancel any or all tenders without assigning any reason whatsoever. The WBPDCL does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDCL authority.
