INVITATION OF BIDS FOR CONSTRUCTION OF 2 (TWO) NO. OF O & M STORE SHED FOR SAGARDIGHI THERMAL POWER PROJECT, PHASE-II EXTENSION UNITS (2X500 MW) IN THE DISTRICT OF MURSHIDABAD

1.0 The West Bengal Power Development Corporation Ltd. (WBPDCL) invites sealed tenders in three (3) bid system from eligible bidders for **Construction of 2 (two) no. of O & M store sheds on comprising of civil and structural works for their Phase – II Extension Units # 3 & 4 (2 X500 MW) of Sagardighi Thermal Power Project.**

Step- I : Deposition of requisite amount of Earnest Money.

Step- II : Submission of documents as per the clause no. 4.0

Step- III : Price Bid.

2.0 Time of Completion:

(i) 10 (Ten) months from the date of Handing over of site.

3.0 Details of Tender:

Special Note:–

Tender documents shall be issued to the respective bidders on submission of the money receipt for the cost tender papers.

a) **Cost of tender document**

[Indian Rupee (INR)] : INR. 5,000.00 (Five thousand) only By crossed Demand Draft/ Pay Order on any Scheduled or Nationalized bank drawn in favour of The West Bengal Power Development Corporation Limited and payable at Kolkata, West Bengal, India

b) **Date for sale of tender document:** From 17.06.2013 to 28.06.2013 up to 15.00 Hrs (IST)

c) **Last date and time for submission of complete tender:** **12.07.2013** (Friday) upto 14.30Hrs.(IST)

d) **Place, date & time for opening of tender** : WBPDCCL Corporate Office, Kolkata, West Bengal on **12.07.2013 at 15.00 Hrs. (IST)**

e) **Bid Security:** All bids must be accompanied by a security as bid security/bid guarantee submitted in a separate sealed envelope in the following mode:

(i) INR. 6,00,000.00 (Rupees six lakh) only By crossed Demand Draft/ Pay Order on any Scheduled or Nationalized bank drawn in favour of The West Bengal Power Development Corporation Limited and payable at Kolkata, West Bengal, India

(ii) By Bank Guarantee – INR 12, 00,000.00 (Rupees Twelve lakh only) issued by any scheduled/nationalized bank. The Bank Guarantee shall remain valid for a period of 270 days from the date of opening of the tender with a claim period of additional 90 days.

Details of the above and the other terms and conditions have been specified in the Conditions of Contract.

4.0 Qualification Requirement and Eligibility Criteria for Bidders

The Bidder shall fulfill satisfactorily the eligibility criteria requirements as stipulated under and submit documentary evidences that:–

4.1 Bidder must possess and has to submit attested photocopies of

(a) Valid I.T & S.T and VAT registration certificates., Service Tax Registration, Professional Tax Clearance Certificates, Provident Fund A/c No and current Bank statement for P F deposits. etc.

(b) Audited balance sheet for last three consecutive years.

4.2 Has executed at least two numbers of similar nature of works in two different work orders consisting of civil and structural works during the last 5 (five) years on turnkey or item rate contracts each valuing not less than 3 (three) crore in a single order or 1.5 (one and half) crore in two different orders and which are in successful operation for not less than 03 (three) years as on date of opening of the bid. As a proof of the above the Bidder shall submit relevant end user's Certificates.

The Bidder shall furnish a comprehensive list of completed jobs and jobs under construction with scope of work, details of the Owner, construction details, dates when contract/s have been awarded and commissioned/handed over.

4.3 a) Have adequate capability and capacity to perform the work covered under this package properly and expeditiously within the time period specified with all necessary materials/equipments/machineries, tools and tackles. List of machineries/equipments etc. likely to be deployed shall be submitted by the bidders.

b) Has an adequate, well established and equipped office set up for undertaking the work of planning and procurement activities, preparation of Bar Bending Schedules, fabrication drawings etc. as and when required.

b) Has an adequate field service organization to provide the necessary supervision during construction, erection and management services required for construction of the Road and drainage work as specified in the tender document.

4.4 The average annual turnover of the bidder in each of the last three financial years on the date of bid opening shall not be less than 3 (three) crore. Net worth of the bidder in each of the last three financial year shall not be less than 1.5 (one and half) crore.

Bidder has to submit annual reports including audited Profit & Loss Account and Balance Sheets for each of the last three financial years.

5.0 On the basis of a written application, tender documents, will be available from the Office of The Director (Projects), WBPDCCL, Bidyut Unnayan Bhawan, Plot No. – 3/C, Block – LA, Sector – III, Salt Lake City, Kolkata – 700 098, during the period as stipulated in clause no. 3C (excluding Saturdays, Sundays & Holidays) from 11.00 Hours (IST) to 15.00 Hours (IST) during all working days against payment of cost of the tender document by cash/ crossed demand draft /pay order on any scheduled bank drawn in favour of “The West Bengal Power Development Corporation Limited” and payable in Kolkata.

6.0 **No tender paper will be sent by post.**

7.0 Tender papers are not transferable.

8.0 The offer must accompany the Bid Security/ Bid Guarantee as indicated above failing which it will not be considered.

9.0 Any offer received after the expiry of the time prescribed for receiving completed tenders, will not be considered. Offer received through e–mail, fax, will not be considered.

10.0 The WBPDCCL reserves the right to reject any tender or all tenders received at its discretion without assigning any reason whatsoever. The WBPDCCL also reserves the right to split the job to different contractors.

11.0 The WBPDCCL is not necessarily bound to accept the lowest offer.

12.0 Issuance of bidding documents will not be construed to mean that such Bidders are automatically considered qualified.

13.0 The Corporation reserves the right to accept / cancel any or all the tenders or to split the work without assigning any reason whatsoever. The WBPDCCL does not bind itself to accept the lowest tender and qualification of bidder will be adjudged as per sole discretion of WBPDCCL authority. The validity of tender will remain effective for 6 (Six) months from the date of opening of Price Bid of tender. All other details will be available in the tender document.
