Sealed tenders of the parties who have deposited the requisite amount of Earnest Money in **Step-I** of the bid; the **Step-II & Step-III** bid thereof will be opened subsequently. After finalisation of the **Step-II & Step-III** bid i.e. fulfillment of the qualification requirement and Techno-Commercial part, the Price-Part of the Bid i.e. **Step-IV** of the eligible tenderers will be opened on a separate date, which will be intimated to the qualified parties later on. All tenders including its various steps shall be opened in presence of tenderers. The dates of opening of Price-Part shall be intimated to the competent tenderers in due course of time.

The Earnest Money should be deposited along with the tender papers in the form of Bank Draft / Call Deposit /Manager's Cheque/ Banker's Cheque on SBI / UBI / PNB / UCO Bank, Mecheda Branch in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LTD." in a separate sealed envelope.
