Step-I : Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirements:

- a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate or challan and Provident Fund Registration Certificate.
- b) Audited balance sheet to satisfy the **net worth** (for the year **2010-2011 or 2011-2012**) of the intending party **not less than Rs. 15 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
2. a) The bidder should have 06 months experience for this type of work.
b) The bidder should submit(along with their offer) contract of similar nature having order value not less than **Rs. 20 lakhs in one year** executed within a period of last five years.

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
