- Name of the job:** As indicated above
- Eligibility Criteria:** The contractor must have experience in execution of at least 01 no. conveyer related structural job valuing minimum Rs.50,000/-, during any one of the three preceding financial years under any Government organization, Govt. undertakings or PSU's, The copy of the work order /s is/are to be submitted along with tender paper in Part-II i.e Techno Commercial Bid.
- Sale of Tender Paper:** From 26/8/2013 to 02/9/2013 on all working days from the office of The Sr.Manager (Utility) from 10:00 Hrs to 14:00 Hours, after application for the same to the Sr. Manager (U), STPS, WBPDCCL is received. Sale of tender paper to the applicants will not qualify them automatically in Techno Commercial Bid. Tender paper will be sold to each applicant. Necessary documents i.e attested photocopies of VAT/ST Registration Certificates with return, PT Challan, Last PF Challan with valid PF registration certificate, IT PAN copy, Last Copy of insurance under W.C Act are to be submitted along with Tender Paper in Part-II i.e Techno-commercial bid. Request for tender paper by post will not be entertained.
- Cost of tender paper:** Rs. 250/- (Non Refundable)
- Pre-bid discussion:** Pre- Bid discussion will be held on 4/9/2013 in presence of attending applicants . Any decision, as an outcome on the discussion (to be displayed on the Notice Board of CHP, Technical Building, STPS) will be binding on all the tenderers and minutes of the said discussion shall be considered as the integral part of the tender specification.
- Receipt of Tenders:** Upto 14:30 Hours on 9/9/2013. Quotation to be submitted in three parts in a single sealed envelope, addressed to The Sr.Manager (Utility), with the description of the job clearly mentioned on the same. The three parts shall consist: 1) Earnest Money deposit 2) Techno-Commercial Bid and 3) Price Bid in separate sealed covers, with these categories written on them. The tender is to be submitted in the tender box available at the office of The Sr.Manager (U),STPS, CHP Technical Building.
- Opening of Tenders:** i) Earnest money of 1 % of quoted amount (minimum) is to be deposited in terms of Pay Order/DD in favour of THE WBPDCCL, payable at UBI, Santaldih and the same along with Techno-commercial Bid will be opened on 9/9/2013 at 15:00 Hrs in presence of attending bidders in the chamber of Sr.Manager (U), STPS. Price bid may be opened at a later date on intimation to Techno-Commercially qualified tenderers. However at any point during the tendering process, non- compliance of deposited earnest money less than 1% of quoted amount is observed in any parties bid, then the same bid shall be entirely cancelled. Unsuccessful bidders shall be given back their earnest money as per normal regulation.

The corporation does not bind itself to accept the rate quoted by the lowest bidder and reserves the right to accept or to reject any or all the tenders or to split the whole work for entrusting the same to more than one contractor.

The validity of the tender shall remain effective without any variation for 04 months from the date of opening of price bid.
