## 2. Eligibility Criteria:

- a) The Agency/Company must have experience in deployment of Security Personnel, in a single contract or more than One contract, engaging at least 200 Security Personnel in any Industrial sector and or at any industry at least in one year or in two spans totaling to 12 months during last 3 (three) years under Government Organizations / Undertakings / any industry of repute/ Autonomous Body representative of Industrial Houses, to be supported by the Performance Certificate / Work order of end User.
- b) Current IT Registration Certificate, PT and Service Tax Registration Certificate to be produce with the tender document.
- c) PF Establishment Code. (PF allotment letter by RO/SRO).
- d) Sound financial condition supported by Audited Balance Sheet for the last 03 (Three) years showing Profit and loss to be produced with the tender documents. (Last financial year being 2013-14).

- e) Minimum last 7 (Seven) years experience in deployment of Security Personnel independently.
- f) The agency must have an annual turnover of Rs.10 corers and above in last financial year.
- h) Having License under the Private Security Agency (Regulation) Act, 2005/The West Bengal Private Security Agencies (Regulation) Rules, 2007 to work in Kolkata.
- 3. **Earnest Money: Rs.50,000/- (Rupees Fifty thousand only)** (interest free) to be deposited in a separate sealed envelope along with the offer.
- 4. Sale of Tender Document: Tender document will be issued on the basis of written application addressed to the General Manager (HR) at the above address from 22.08.2013 to 30.08.2013 on all working days, between 11.00 hrs to 15.00 hrs, except Saturdays & holidays. Issuance of tender documents will not construed to mean that such intending bidders are automatically considered qualified. Request for tender paper by post will not be entertained. - 5. **Cost of Tender Document**: Rs.6000/- (Six Thousand Only) [Non-refundable] as mentioned above by Cash only.
- 6. **Contract Period:** Contract will be for **18 (Eighteen) months**. However order will be placed initially for 12 months which may be extended for a further period of 06 (Six) months at the same ordered terms and condition, at the sole discretion of the management depending upon satisfactory performance and conduct.
- 7. **Pre-Bid discussion:** On 02.09.2013 at 15.00 hrs in presence of attending tenderer. The clarification(s)/decision against point/query as would be given by WBPDCL during Pre-Bid shall form integral part of this NIT& shall be binding on all the tenderers. The Agency who purchased Tender Documents but not attended the Pre Bid discussions shall have to comply to the decision of Pre bid discussions.
- 8. **Submission of Tenders: Upto 14.00 hrs of 06.09.2013** to be submitted in three parts i.e.1) Earnest Money 2) Qualifying requirement 3) Price-Bid in a separate sealed envelope, indicating specific part on the envelop.
- 9. **Opening of Tender:** Step-I i.e. Earnest money and Step-II i.e. Qualifying requirement will be opened on **06.09.2013 at 15.00 hrs** in presence of attending bidders. Price Bid (Step –III) of the qualified bidders in Step–I & Step-II will be opened on **13.09.2013 at 15.00 hrs**.
- 10. The Tender/Bid will remain effective for 6 (six) months from the date of opening of Price Bid.
