- (ii) Credential of excavation and disposal of earth, river sand and evacuation of settled ash from ash ponds directly under a Government/ Quasi Govt. organization / reputed private organisation, at least once within the period of last seven years with a satisfactory completion certificate indicating the main work order no. and the value of work, scheduled and actual time of completion.

The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-

- a) In Single order of value not less than- Rs 3.40 crore.
- b) In two orders each of value not less than- Rs. 2.15 crore.
- c) In three orders each of value not less than –Rs. 1.70 crore.

Evacuation of settled ash from the Ash pond in operation, transportation and disposal in eco-friendly manner from Bakreswar Thermal Power Project, at Dist. Birbhum, West Bengal.
