- a) Must have experience of similar type of job or Civil Construction/ Maintenance job of individual order value not less than **Rs. 4, 45, 025.00** during at least one out of five preceding financial years for which completion certificate or work order with schedule is to be submitted along with tender paper in part-II i.e. Techno-commercial bid.
- b) Must be financially strong— Balance sheets with profit & loss account for the consecutive two financial years of last three years or current Bank Statement are to be submitted along with tender paper in part-II i.e. Techno-commercial bid & pre-qualification bid.
- c) Must be technically capable-
