The West Bengal Power Development Corporation Limited (WBPDC) invites sealed tenders from experienced agencies in four part bid system containing EMD (Cover-I), Qualifying Requirements for the bidders (Cover -II), Techno-Commercial Bid (Cover -III) and Price Bid (Cover -IV) for supply of beneficiated coal from existing washeries in the vicinity of Lakhanpur, Lajkura, Samleshwari area (**IB-Valley coalfields**) of MCL to the power station(s) of The WBPDC.

Period of contract - **2 (Two) Years with a provision of extension of further six months with the same terms and conditions.**

Total quantity to be beneficiated - **2.5 (Two and decimal five) Million Metric Tonnes** per year in terms of raw coal

1. SCOPE OF WORK

Supply of beneficiated coal on FOR, destination basis by coal beneficiation plant(s) in Ib Valley area of MCL, including transportation of washed coal to Railway siding in **Ib valley** area of MCL and loading into wagons for onward movement to the power station (s) under WBPDC by Rail. The scope of work inter alia includes beneficiation of approximately **2.5(Two and decimal five) Million** Metric Tonne per year in terms of raw coal per annum by utilizing the raw coal allotment on account of WBPDC i.r.t. FSA between WBPDC and MCL.

The scope thus involves;

- i. Taking delivery of raw coal from the mines of MCL with necessary follow up with MCL
- ii. Transportation of the raw coal to washery and beneficiation of raw coal at washery.
- iii. Transportation of beneficiated coal to railway siding.
- iv. Arrangement of empty rakes with all necessary liaison /expediting with Railway Authorities. The sole responsibility of arrangement of rakes will lie on the washery operator and WBPDCCL will not be responsible in any way for unavailability of empty rakes.
- v. Loading of beneficiated coal into railway wagons for onward movement to power plants under WBPDCCL.

2 Qualifying requirements for tenderers:

The Bidders shall possess following minimum qualifying requirements:

- 2.1 Location of the washery should be in the vicinity of **Ib valley coalfields** of M/s Mahanadi Coal Fields Limited, Orissa as proximate to the Mines and to the Railhead as possible.
- 2.2 The washery as stipulated in 2.1 must have a minimum washing capacity of 2.5 Million Tonnes per annum in terms of RAW COAL. Necessary Clearance Certificates from appropriate authorities must be submitted to support the qualification.
- 2.3 The bidder must be capable to commence supply washed coal from their washery within ten days after release of Delivery order by MCL.
- 2.4 Tenders received from those not having the requisite experience, tools and plant shall not be considered. The tenderer must provide a declaration with relevant supporting documents in this regard.
- 2.5 Normally no deviation in respect to Technical specification and terms and conditions incorporated in the tender specification will be allowed. In this regard declaration has to be submitted along with tender documents by the tenderer. However in case of any deviation, same should be clearly specified in qualification schedule as per **Annexure -I**. WBPDCCL reserves the sole right to accept or reject the deviation sought by the bidder.
- 2.6 Net worth of the bidder should be Rupees **15 crores** in the preceding financial year. Relevant Documents need to be submitted.
- 2.7 Annual turnover should be Rupees **30 crores** on an average in last three financial years. Relevant Documents need to be submitted.

- 2.8 Those tenders which contain the full information and which comply with the requirements regarding technical and financial qualifications will be considered. Notwithstanding anything stated above, WBPDCCL reserves the right to assess the bidder's capacity to execute the contract, should the circumstances warrant such assessment in the overall interest of WBPDCCL. In this regard the decision of the Corporation is final.
- 2.9 The bidder shall furnish the following information, inter alia in **Annexure -I** with Part II of the tender.
- a. Capacity details of coal washery in terms of raw coal and washed coal
 - b. Spare capacity available to meet the requirement of WBPDCCL
 - c. Relevant certificates in proof of the existence of the washery.
- 2.10 The tenderer should have at least **one year** satisfactory performance record of running washery owned by the tenderer as stipulated in 2.1. Relevant document in support has to be submitted along with the tender document in **Annexure - I.**

3. Earnest Money

The bidder has to deposit requisite earnest money along with the tender to ensure that the tenderer takes up the work in right earnest.

Earnest money amounting to Rs 2.4 crore (Rupees Two and decimal four crores) in the form of Bank Draft drawn in favour of The West Bengal Power Development Corporation Limited, payable at Kolkata or Rs 4 Crore (Rupees four crore) in the form of Bank Guarantee from any Nationalized Bank/Scheduled Bank/Foreign Bank with office in India will have to be deposited. The Validity of the EMD shall be 90 days from the date of submission of Bid.

For the successful L1 bidder, the EMD will be released without interest after submission of the security deposit.

The Earnest Money of unsuccessful bidder(s) shall be released in due course of time without any interest. The EMD may be forfeited as per Clause No. 4.4 of Volume I of the Tender.

Tender submitted without Earnest Money Deposit is liable of rejection.

The West Bengal Power Development Corporation Limited (WBPDC) invites sealed tenders from experienced agencies in four part bid system containing EMD (Cover-I), Qualifying Requirements for the bidders (Cover-II), Techno-Commercial Bid (Cover-III) and Price Bid (Cover-IV) for supply of beneficiated coal from existing washeries in the vicinity of Basundhara, Kulda area (**IB-Valley coalfields**) of MCL to the power station(s) of The WBPDC.

Period of contract - 2 (Two) Years with a provision of extension of further six months with the same terms and conditions.

Total quantity to be beneficiated - 2.5 (Two and decimal five) Million Metric Tonnes per year in terms of raw coal
