INFORMATION TO BIDDERS: This is a Four Part bidding system containing Earnest Money (Part-I), Qualifying Requirement (Part-II), Techno-Commercial (Part-III) and Price Bid (Part-IV). The same will be received and evaluated by the WBPDCL, STPS from Technical and Financial point of view to make a selection in the best interest of the WBPDCL, STPS for the complete work covered under the tender document.

- 1) <u>Earnest Money</u>: The Earnest Money of Rs.1,50,000/- (Rupees One Lac and Fifty Thousands Only) shall be deposited along with tender papers in the form of Bank Draft / Pay Order in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" payable at **United Bank of India, Santaldih Branch, Dist. Purulia.**
- 2) A) Total financial involvement: Rs.75 Lacs
 - B) Contract Period: Two (2) Years.
- 3) Cost of Tender Paper: Rs. 6,000.00 (Rupees Six Thousand Only).
- 4) Eligible Criteria / Credential:

A) Credential:

- i) <u>Financial</u>: Should have experience in executing contracts of monetary involvement more than **28 lacs per year** in a **single order** during at least **one out of three preceding years** for which **completion certificate** or **work order** with schedule is to be submitted with tender paper in Part II i.e. Qualifying Requirements.
- **ii)** <u>Technical</u>: Should be well experienced in different mechanical maintenance jobs of 250/210 MW BHEL corner fired boiler, Gravimetric Coal feeder, High pressure valve, coal carrying pipe, shoot blower etc. of some reputed power plant. Supporting document should be submitted with the tender paper in Part-II i.e. Qualifying Requirements.
- **B) Must be financially strong**: **Audited balance sheet** with profit & loss account for the last three years and Bank statement are to be submitted along with tender documents in Part II i.e. Qualifying Requirements.
- C) Must be technically capable to do the job for 210 MW Units or higher capacity.

Sale of tender paper to the applicant will not qualify them automatically in Techno-Commercial bid. Tender paper will be sold to each of the applicants. - (j) **Documents in support of** (i) Sound Financial Capability & (ii) Credentials of executing the job of this type for the Unit of 210 MW or above for at least 1 (One) year or above, Copies of Work Orders of similar jobs for the Unit of 210 MW or above of adequate order value more than Rs. 28 (Twenty Eight) Lacs per annum in a single order executed / being executed for one year out of three preceding years for which completion certificate or work order with schedule is to be submitted.

The WBPDCL reserves the right to cancel the quotation in absence of the above documents at their discretion.

- 5.1: The WBPDCL reserves the right to cancel / accept the tender in absence of the documents at their discretion in case competent authority deems it.
- 5.2: Legible photocopies of all documents are to be submitted with counter signed & sealed by the agency. Original copies of documents are to be produced on demand.
- 5.3: The tender, Qualification of bidder (Part-II) shall contain the name, Residential Address, Phone Number, Fax Number, e-mail id of person(s) authorized to sign the tender for future contact.
- 5.4: Capability of making Labour Payment within 10'th of every month without looking forward for release of bill from F&A Deptt., STPS.
- 5.5: Capability to control the labours with sufficient command and confidence.
- 6) <u>Pre-Bid Discussion</u>: It is intended to have a pre-bid discussion at this Office of Sr. Manager(M&C), STPS on 23.09.2013 at 15=30 Hrs. to provide any additional information and furnish clarification, if any, needed on the scope of work and tender documents. 8) Opening of Tender:

- 8.1 : The tenders shall be opened in presence of representative of the agency at the time of date set for opening of tender as specified hereunder or in case any extension has been given thereto on the extended tender opening date and time notified to all the agencies who have purchased the tender documents. Agency's authorized representative (up to two persons) may attend the opening.
- 8.2: The due date and time of opening of E.M.D.(part-I) & Qualifying Requirement (part-II) after 15=15 Hrs. on 30-10-2013. After opening the main cover, the envelope containing EMD (Part-I) shall be opened first and if EMD of requisite amount in proper mode is found only then Qualifying Requirement (QR) (Part-II) shall be opened.
- 8.3 : Techno Commercial (Part-III) of tender of those agency who will be considered qualified in view of Part-I and Part-II by the WBPDCL, shall be opened subsequently at a later date. The due date and time for opening of Techno Commercial part shall be duly intimated.
- 8.4: Price Bid (Part-IV) of tender of those agencies who will satisfy qualifying requirements and who will accept technical and commercial terms & conditions of this tender shall be opened subsequently at a later date. The due date & time of opening of price bid will be duly intimated.

9) Evaluation of Tender:

- 9.1: Issuance of tender documents will not mean that such agency are automatically considered qualified for the entire tender process.
- 9.2: The WBPDCL reserves the right to itself to accept any tender or reject any or all tenders or cancel / withdraw the invitation for tender without assigning any reason for such decision. Such decision by the WBPDCL shall not be subject to question by any agency and the WBPDCL shall bear no liability consequent upon such decision and the agency shall have no claim in this regard against the WBPDCL.
- 9.3: Evaluation by the WBPDCL shall be based on the information and documentary evidence submitted by the agency in response to the tender documents. The requirements as stipulated in the tender notice and documents are the minimum and the WBPDCL has the right to request for additional information. The WBPDCL reserves its right to reject any tender, if in the opinion of the WBPDCL the qualification data / documentary evidence submitted by the agency is incomplete or agency is found not qualified to satisfactorily perform the work. The WBPDCL reserve the right to reject any tender if the agency is found to be disqualified by giving incorrect and / or false information.
