04. **Earnest money:** Rs.1,50,000/- (One Lac Fifty Thousand) to be submitted in form of Bank Guarantee or DD on Scheduled Bank only. Govt./ Govt. Undertaking/SSI/NSIC units are exempted from deposition of E.M. Valid documents shall have to be submitted along with tender for claiming exemption.
05. **Qualifying Requirement:** All the documents as stated under are to be submitted in a sealed envelope:
- 1) Must be a manufacturer of Hi-Chrome Grinding Balls of size 730mm dia. & Ni-Hard Grinding Ring set for Ball Mills & should have supplied Grinding Ring & Balls during last 07 (seven) years (as on the date of bid opening) as any of the following:
 - a) One similar executed order having value not less than Rs.150.00 Lacs OR
 - b) Two similar executed orders having value not less than Rs.100.00 Lacs each OR
 - c) Three similar executed orders having value not less than Rs.50.00 Lacs each
 - 2) The Bidder should have the testing facilities including Chemical, Physical & NDT.
 - 3) The average annual turn over of the bidder in the three preceding completed financial years, as on the date of Bid opening shall not be less than Rs.500.00 Lacs.
 - 4) The bidder must have manufactured & supplied Grinding Ring & Balls which have satisfactorily run in coal mill of any power utility having generation capacity of atleast 210 MW, at least for a period of 8000 hours from the date of commissioning of the same.
 - 5) For manufacturers who have not supplied identical material yet to any power station of West Bengal Power Development Corporation may not be awarded with full quantity and WBPDCCL at its discretion, in the event of placement of order, may reduce the quantity to 25% for observing performance.

Tender may be cancelled at any stage without assigning any reason whatsoever.
