 - B) Contract Period: Till completion Overhauling Job (as per scope of work).

- 4) Eligible Criteria / Credential:

Qualifying Requirements: -

(A) Technical:-

- i) The bidder must have the experience of carrying out Erection / Maintenance / overhauling of 250 MW Boiler or above (Steaming capacity > or = 800 TPH). The bidder should furnish credentials along with bid documents in support of similar works executed from any Central / State Government / PSU / reputed industrial organization / utility.
- ii) The bidder must be IBR approved agency. (Approved documents in the name of the agency from concerned IBR approving authority, to be submitted along with bid documents)
- iii) The agency must be categorized as special class repairer of Boiler U/R 392 of Indian Boiler regulation by Directorate of Factories & Boilers, West Bengal.

(B) Financial:-

- i) The bidder should have experience of having executed similar work orders with value of Rs.90 Lac in case of single similar order during last three (03) years reckoned as on the date of bid opening.

- iii) Other income shall not be considered for arriving at annual turnover as specified.

(C) Additional information:-

- i) Notwithstanding anything stated above, WBPDCL reserves the right to assess the bidder's capability and capacities to perform the contract. If the circumstances so warrant, the QR may be modified in overall interest of work. The employer also reserves the right to reject any or all bids or cancel / withdraw the invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

8) Opening of Tender:

Agency's authorized representative (up to two persons) may attend the opening.
- 8.2: The due date and time of opening of E.M.D.(part-I) & Qualifying Requirement (part-II) after 15=15 Hrs. on 18-12-2013. After opening the main cover, the envelope containing EMD (Part-I) shall be opened first and if EMD of requisite amount in proper mode is found only then Qualifying Requirement (QR) (Part-II) shall be opened.
- 8.3 : Techno Commercial (Part-III) of tender of those agency who will be considered qualified in view of Part-I and Part-II by the WBPDCL, shall be opened subsequently at a later date. The due date and time for opening of Techno Commercial part shall be duly intimated.
