- 2. Eligibility criteria:-
- a) Must have experience of similar type of job or civil construction/ civil maintenance job of individual order value not less than Rs. 3,93,000.00 during at least one out of five preceding financial years for which completion certificate or work order with schedule is to be submitted along with tender paper in part-II i.e. Techno commercial bid.
- b) Must be financially strong: Balance sheets with profit & loss account for the consecutive two financial years of last three years or current Bank Statement are to be submitted along with tender paper in part-II i.e. Techno commercial bid & pre-qualification bid.
