Sub: Tender Notice for Annual Service Maintenance of Mill rejection of Stage-II Unit (Unit # 4 & 5) & Soot Blowing of all Unit (Unit # 1 to 5) of BHEL make Corner Fired 210 MW Boiler of Bakreswar Thermal Power Project

Bakreswar Thermal Power Project (BkTPP) invites 4-part Bids [Part I – Bid Guarantee (EMD), Part II- Pre Bid Qualification, Part III- Techno Commercial Offer, Part IV- Price Offer] offer for undertaking the job of **Service Maintenance of Mill rejection of Stage-II (Unit # 4 & 5) & Soot Blowing** System 210 MW Boiler of BkTPP.

- (1) **Issue of Tender Document:** The tender document shall be available from the **Contract Cell, Administrative Building (3rd floor), BkTPP** from 09:00 Hrs. to 11:30 Hrs. and 15:00 Hrs. to 17:00 Hrs. except Holidays & Sundays. **For collection of tender paper, the agency must send their authorized person with office stamp/seal.**
- (2) **Cost of Tender Document :** The tender document shall be issued against submission of non-refundable **Demand Draft/Pay order amounting Rs.500.00** (Rupees five hundred) only **drawn in favour of “The West Bengal Power Development Corporation Ltd ” payable at any Nationalized /Scheduled Bank at Suri or United Bank of India at Bakreswar T.P.P Branch.** Tender paper shall not be issued against cash / cheque / money order or by post.
- (3) **Sale of Tender Document: From 09/12/2013 to 20/12/2013 (up to 17:00Hrs) from Publication date.**
- (4) **Pre-bid discussion: On 23/12/2013 at 15:30 Hrs at the Administrative Bldg., BkTPP**
- (5) **The last date & time of submission of Bid: 27/12/2013 Up to 15:00 Hrs.**
- (6) **Time of submission of Bid: After pre-Bid Discussion the Tender Bid will be allowed to be submitted on every working day from 09:00 to 11:30 hrs and 14:30 to 17:00 hrs(Except for last date of submission-09:00 hrs to 11:30 hrs and 14:30 hrs to 15:00 hrs.**
- (7) **The date & time of opening of part- I, II & III of the Bid: 27/12/2013 at 15:30 Hrs at Contract Cell, Administrative Building (2nd floor), Bakreswar Thermal Power Project.**
- (8) **If all the above mentioned fixed up date & time fall on a holiday/festival or any sudden declared holiday then the dates will be shifted to the next working day. WBDCL authority reserves the right to change the above fixed date at their own discretion.**
- (9) The date & time of opening of price bid will be intimated in due course to the Techno-commercially successful bidder.
- (10) The **Bid Guarantee** is to be submitted along with the bid in the form of Demand Draft/Pay order amounting **Rs. 1, 00,000/-** (Rupees One Lakhs) only **drawn in favour of “The West Bengal Power Development Corporation Ltd ” payable at any Nationalized /Scheduled Bank at Suri or United Bank of India at Bakreswar T.P.P Branch.** The Bid Guarantee of unsuccessful bidder shall be released in due course of time without any interest but may be forfeited at the sole discretion of WBDCL in case of submission of any false document in support of technical or financial credential of

the bidder. However, necessary relaxation in the Bid Guarantee amount may be allowed to the bidder, if they are governed by any particular Circular/Administrative order for a defined period, coverable within the scope of the contract, on production of supporting documents. Original Order of relaxation is to be shown if required.

- (11) Acceptance of offers is subject to submission of valid Sales tax clearance certificate/VAT [up to date & if applicable], Professional Tax Clearance Certificate [up to date], Income Tax PAN No , Service Tax Registration No , PF code etc. along with the offer.
- (12) **Before preparing the tender for final submission, the agencies must collect all relevant information from the DGM (HR&A), BkTPP regarding procedure of deployment of manpower, prevailing wages of unskilled manpower at BkTPP, Provident Fund, Workmen's Compensatory Insurance, Labour License and all other stipulated Rules & Regulations under the Factories act -1948 & rules frame under Contract Labour (R&A) 1970 & rules framed there under, Minimum Wages act and other statutes applicable including Rules and Regulations connected thereto.**
- (13) The interested agencies may inspect the site & satisfy themselves before submission of tenders. The bidder must confirm in written while submitting the tender that he has quoted rates understanding the scope & area of work, all terms and conditions of tender documents, mode of deployment of manpower at BkTPP, actual site conditions & other related aspects. **For any clarification regarding Scope of works/area etc, the agency may contact Sr. Manager (Operation) BkTPP.**
Deviation in any respect, expressed anywhere in the four part bid document, will not be accepted.
- (14) **Qualification of the Bidder :** The tender is open to any single Bidder who is a well established and reputed company meeting the following requirements :
- a) **Working Experience:**
- i) **Operation or Maintenance or construction or commissioning experience in Mill Rejection System (Bowel Mill, Model XRP883) also well experienced in soot blowing System of BHEL make Corner Fired 210 MW Boiler.**
 - ii) **Experience list and performance certificate from the end-user and photo copy of orders are to be furnished along with the offer.**
 - iii) **One similar Completed work costing not less then amount the equal to Rs 15 lakhs (Fifteen) for Mill Rejection and Rs 08 lakhs (Eight) for Soot Blowing should have to be submitted along with the offer.**
- b) **Financial ability:**
The bidder should have adequate financial stability i.e. annual turnover shall be more than Rs. 20, 00,000.00 (Twenty Lakhs) and net worth not less than Rs. 2,00,000.00 (Two Lakhs) in each of the last two years. The copy of audited accounts with report for last two consecutive years has to be furnished along with the offer.

(15) **Price to be quoted:**

Rate Contract Price: Lump Sum Contract Price : The bidder must quote total lump sum contract price along with cost break-up for one year as per scope detailed in tender document (excluding the service tax) for Service Maintenance of Mill rejection system of (Unit # 4 & 5) & Soot blowing System of Bakreswar Thermal Power Project including supply of manpower and allied expenses like accommodation, vehicle, overhead and profit, consumables, tools & tackles, Personal Protective Equipments for the manpower and other incidental expenses. This LS contract price will remain net & firm for **one and half year** and any conditional bidding with price variation cost will make the bid liable to cancellation.

The bidder must indicate the breakup of the quoted L.S. contract price i.e. cost involvement for deployment of manpower (category-wise), consumables, tools & tackles, overhead expenses and profit of the bidder. Service tax, as applicable, will be paid extra against submission of proper document.

L-1 bidder will be considered with the summation of L.S contract price of Mill rejection system & Soot blowing System

Period of contract: The period of contract shall be **01 (one)** years from the actual date of commencement of work at site. Contract period may be extended up to further six months without any price escalation i.e. at the same lump sum monthly rate of the order at the discretion of WBPDC provided the performance of the previous year is satisfactory.

- (16) **Consumables, Tools & tackles etc required for work:** Shall be provided by the contractor free of cost.
- (17) Apart from above following stipulations are to be adhered to :-
Tender papers are not transferable.
- Any offer without aforesaid bid guarantee shall not be considered
 - Any offer received after the last date & time stipulated in this notice shall not be considered.
 - WBPDCCL reserves the right to reject any or all tenders at its discretion at any time.
 - WBPDCCL is not necessarily bound to accept the lowest offer
 - Issuance of tender paper will not ascertain the qualification of the Bidder.
 - Minutes of Pre-bid discussion will be treated as a part of Tender Documents.
 - Minutes of Pre-bid discussion is to be signed by the attending authorized representative of the bidder.
 - Any offer at any stage of evaluation may be rejected and the Bid Guarantee shall be forfeited at the sole discretion of WBPDCCL in case of submission of any false document in support of credential [financial or technical] of the bidder.
 - No deviation is allowed in respect of any terms & conditions detailed above and appended in the tender paper.
 - Any tender having such deviation expressed anywhere in the bid may be liable for rejection.
 - Jurisdiction regarding this contract is limited to state of West Bengal as per provision of statutes.
 - Offer as a whole [Techno-commercial & price bid] should be prepared with due consideration of bid documents.
